AUTHORIZING THE REALIGNMENT OF APPROPRIATIONS IN THE
OFFICE OF THE SANGGUNIANG PANLUNGSOD

WHEREAS, Section 336 of the Local Government Code of 1991 states:

Section 336. Use of Appropriated Funds and Savings. Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. **However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance,** be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in Session assembled:

SECTION 1. TITLE. This Ordinance shall be called "Ordinance Authorizing the Realignment of Appropriations in the Office of the Sangguniang Panlungsod".

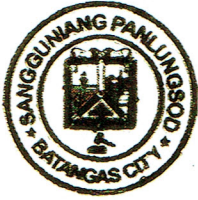
SECTION 2. REALIGNMENT. The realignment of appropriation in the Office of the Sangguniang Panlungsod is hereby approved and authorized:



SECTION 6. EFFECTIVITY. This Ordinance shall take effect upon approval of the City Mayor.



ACTION TAKEN ON REALIGNMENT OF APPROPRIATIONS


Finding no legal impediment for the approval of the requested realignment, the Committee recommends the approval of request of the Honorable City Vice Mayor.
