AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY FOUR MILLION FOUR HUNDRED EIGHT THOUSAND SEVEN HUNDRED FIFTEEN PESOS AND FIFTY FOUR CENTAVOS (P24,408,715.54) FOR THE SUPPLEMENTAL BUDGET NO. 2 OF THE CITY GOVERNMENT OF BATANGAS FOR CALENDAR YEAR 2014

WHEREAS, on September 17, 2014, the Honorable City Mayor Eduardo B. Dimacuha submitted to the Sangguniang Panlungsod the proposed Supplemental Budget No. 2 of the City Government of Batangas for Calendar Year 2014 amounting to P24,408,715.54 for legislation and authorization;

WHEREAS, the funding sources for the Supplemental Budget No. 2 of the City Government comes from the Share from PCSO (P938,715.54) and Re-alignment/Reversion Savings (P23,470,000.00);

WHEREAS, an examination and analysis of the documentary requirements, the program of appropriations, the objects of expenditure show no legal impediment for the approval of the Supplemental Budget No. 2 of the City Government of Batangas;

WHEREAS, the approval of the Supplemental Budget No. 2 is in accordance with the Supplemental Annual Investment Program No. 2 of the City Government for FY 2014.

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BATANGAS CITY THAT:

SECTION 1. TITLE - This Ordinance shall be known and cited as the "Supplemental Budget No. 2 of the City Government of Batangas for Calendar Year 2014".

SECTION 2. APPROPRIATION OF FUNDS - There is hereby appropriated from the General Fund of the City Treasury the amount of Twenty Four Million Four Hundred Eight Thousand Seven Hundred Fifteen Pesos and Fifty Four Centavos (P24,408,715.54) from the Share from PCSO (P938,715.54) and Re-alignment/Reversion Savings (P23,470,000.00) which are free from any obligation or encumbrance as certified by the Local Finance Committee, and which are available for Supplemental Appropriation in accordance with the Objects of Expenditure as enumerated in the statement of Supplemental Appropriation (LBP Form No. 10.)

SECTION 3. COMPLIANCE

3.1 Any change in the budget shall be in accordance with the provision of Section 321 of the Local Government Code of 1991.

- **SECTION 4. REPEALING CLAUSE -** All ordinances, rules and regulations, orders or parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
- **SECTION 5. SEPARABILITY CLAUSE -** If for any reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected shall continue to be in full force and effects.

SECTION 6. EFFECTIVITY - This Ordinance shall take effect upon approval of the City Mayor.

COMMENT / RECOMMENDATIONS:

On September 29, 2014 the Sangguniang Panlungsod referred to the Committee on Appropriations for study, comment and recommendation the letter of the Honorable City Mayor dated September 17, 2014, the proposed Supplemental Budget No. 2 of the City Government of Batangas for Calendar Year 2014 amounting to P 24,408,715.54 for legislation and authorization.

Present during the Committee Hearing were the Chairman of Committee on Appropriations Councilor Alyssa Renee A. Cruz-Atienza, Coun. Armando C. Lazarte and Coun. Gerardo A. Dela Roca, as members. Also present were the members of the Sangguniang Panlungsod, Coun. Glenn M. Aldover, Coun. Aileen Grace A. Montalbo, Coun. Sergie Rex M. Atienza, Coun. Ma.Kristine Josefina G. Balmes, and Vice Mayor, Dr. Emilio Francisco A. Berberabe Jr., Ms. Aster P. Marasigan of City Accounting Office, Ms. Maria Teresa T. Geron of CTO, Ms. Elizabeth Q. Delos Reyes of CBO and Engr. Januario B. Godoy of CPDO.

The chairman of the Committee on Appropriations briefly made on overview of the documents attached to the proposed Supplemental Budget No. 2 of the City of Batangas.

As stated in the budget documents, the sources of funds for the supplemental budget come from the Share from PCSO (P 938,715.54) and Re-alignment/Reversion Savings (P 23,470,000.00). Hence, the total amount of savings available for appropriation is Twenty Four Million Four Hundred Eight Thousand Seven Hundred Fifteen Pesos and Fifty Four centavos (P 24,408,715.54).

The statement of funding sources and the different savings were certified correct by the City Treasurer and the Assistant City Accountant – OIC.
