### AN ORDINANCE AUTHORIZING BUDGETARY AUGMENTATION IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD

SPONSORED BY : COMMITTEE ON APPROPRIATIONS

**WHEREAS**, Section 336 of the Local Government Code authorizes the City Vice Mayor to augment any item in the approved budget from savings in other items within the same expense class;

**WHEREAS**, there is a need to augment item Travelling Expense (Foreign) in the Office of the Sangguniang Panlungsod because the appropriated amount thereto is already insufficient;

**NOW THEREFORE**, the Sangguniang Panlungsod in session duly assembled ordains and decrees:

**SECTION I. TITLE.** This Ordinance shall be called "AN ORDINANCE AUTHORIZING BUDGETARY AUGMENTATION IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD".

**SECTION II. SOURCE OF FUND.** The source of fund available for appropriation by way of budgetary augmentations shall come from item Travelling Expenses (Local) to Travelling Expenses (Foreign).

**FROM**

Travelling Expense (Local) (-751) P 600,000.00

**TO**

Travelling Expense (Foreign) (-752) P 600,000.00

**SECTION III. AUGMENTATION APPROPRIATION.** The City Vice Mayor is hereby authorized to augment item Travelling Expense (Foreign) in the Office of the Sangguniang Panlungsod.

**SECTION IV. CONDITIONS.** The disbursement and expenditures of funds herein provided shall comply with the requirements and limitations provided in the Local Government Code, Guidelines and Procedures and all accounting and auditing rules and regulations.


