WHEREAS, on February 7, 2019, the Honorable City Mayor in her letter, requested for the grant of authority to purchase various vehicles for the use of various offices of the City Government of Batangas;

WHEREAS, there is a need to purchase the following vehicles to support the operation and services rendered by various offices of the City Government of Batangas;

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in session assembled:

**SECTION 1. TITLE.** - This Ordinance shall be called "Ordinance Authorizing the Honorable City Mayor, Beverley Rose A. Dimacuha to Purchase Vehicles for the Use of Various Offices."

**SECTION 2. APPROPRIATION.** - The appropriation for the purchase of various vehicles was hereby approved and authorized:

One (1) unit Passenger Van  
For the use of the City Veterinary and Agricultural Services Office, Batangas City

Twelve (12) units Sports Utility Vehicle  
For the use of Batangas City Government  
2,400 cc  
Diesel Fed  
4 cylinders

One (1) unit Pick-up type Vehicle  
For the use of Bureau of Fire Protection  
2,400 cc  
Diesel Fed  
4 cylinders

**SECTION 3. AUTHORITY.** - The City Mayor is hereby authorized to sign all documents necessary to effectuate the said purchase of vehicles.

**SECTION 4. COMPLIANCE.** - Compliance to all auditing rules, regulations and circulars issued by COA and the Department of Finance shall be strictly complied with by the Officials concerned.

**SECTION 5. SEPARABILITY CLAUSE.** - If for any reason any part of this Ordinance shall be held unconstitutional or invalid other parts thereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 6. EFFECTIVITY.** - This Ordinance shall take effect upon approval of the City Mayor.





KAG. S. ATIENZA: Thank you Mr. Presiding Officer, for item no. 1 since our, earlier we introduce a motion for the suspension of the rules, no. 1 is a letter from the City Mayor Beverly Rose A, Dimacuha requesting for the passage of

an Ordinance granting the City Government the Authority to purchase One(1) unit Passenger Van For use of the City Veterinary and Agricultural Services Office, Batangas City, Ten (10) units Sports Utility Vehicle For use of Batanags City Government, One (1) unit Pick-up Type Vehicle For use of Bureau of Fire Protection, One (1) unit Sports Utility Vehicle For use of City Engineer's Office, and as I remembered it correctly Mr. Presiding Officer, this items are already included in our Annual Budget and AIP, I move for the two minutes recess Mr. Presiding Officer.

**CHAIR:** There's a motion for two-minute recess, before, yes Councilor Julian Villena you are now recognized.

**KAG. VILLENA:** Thank you Mr. Presiding officer, with regards to item no. 1 letter b yong ten units of sports utility vehicle for use of Batangas City Government, I would suggest na gawin na pong labing isa ito, kasi kung ito ho ay yong sa Sanggunian ay papaano po ang Vice Mayor, ay di ho ay wala ang Vice Mayor, kaya siguro mas maganda..

ATIENZA:** Thank you Mr. Presiding officer, since certain ordinance be drafted, to address this request Mr. Presiding Officer, I move that an ordinance be enacted for first, second and third reading, granting authority to the City Government to purchase the aforementioned vehicles Mr. Presiding Officer, provided that if the ten units of sports utility vehicle will be, if there would be an additional to the ten units sports utility vehicle let it be incorporated to the said ordinance Mr. Presiding Officer.

**CHAIR:** Councilor Serge Atienza you're now recognized again.

**KAG. S. ATIENZA:** I would like to reiterate my motion Mr. Presiding Officer that the ordinance be enacted granting the City Government authority to purchase (a) One unit passenger van, (b) Eleven (11) units sports utility vehicle, that would be the discretion if we grant 11, if purchase 11 that will be good and if there would be some discrepancies then we can only purchase lesser number, letter c one unit pick-up type vehicle for the use of Fire Protection and d one unit sports vehicle for the use of City Engineer's Office Mr. Presiding Officer exempting it from the three reading rules, I so move Mr. Presiding Officer.

**CHAIR:** Thank you Councilor Serge Atienza, there's a motion that the passage of an ordinance granting the City Government



the Authority to Purchase the said vehicles duly seconded by Councilor Atty. Allyssa Cruz be approve exempting it from the three reading rule, Councilor Gerry Dela Roca you're now recognized.

**KAG. G. DELA ROCA:** Thank you very much Mr. Presiding Officer, awhile ago the proponent suggested to have ten sports utility vehicle, for me I think it's to have eleven, considering that we have SK Chairman, so all in all I think it's fifteen but since three vehicle already so there's still twelve units of, including Vice Mayor.

**CHAIR:** Councilor Hamilton Blanco you're now recognized. Thank you Councilor Gerry for that manifestation. Councilor Serge Atienza.

**KAG. S.
