RESOLUTION NO. 128 S. 2014

ADOPTING THE REPORT OF THE COMMITTEE ON LAWS, RULES AND ORDINANCES REGARDING THE PROPOSED ORDINANCES ENTITLED: "AN ORDINANCE ALLOWING ALL CINEMAS AND MOVIE THEATERS IN BATANGAS CITY TO ADD TWO PESOS (PHP 2.00) SURCHARGE ON ALL TICKETS SOLD TO MOVIEGOERS AS CONTRIBUTION TO THE PHILIPPINE NATIONAL RED CROSS (PNRC), BATANGAS CHAPTER FOR A PERIOD OF SIX-MONTHS FROM MAY 8 TO NOVEMBER 8 EVERY YEAR", AND "AN ORDINANCE ALLOWING AND REQUIRING ALL CINEMA OWNERS AND OPERATORS WITHIN THE TERRITORIAL JURISDICTION OF BATANGAS CITY TO APPEND IN THEIR THEATER TICKETS, (PHP 2.00) COVERING THE PERIOD OF NOVEMBER 9, 2014 TO MAY 7, 2015 TO SUPPORT THE OPERATION, PROGRAMS AND ACTIVITIES OF THE BOY SCOUTS OF THE PHILIPPINES, BATANGAS CITY COUNCIL", AND SCHEDULING THE SAME FOR SECOND READING IN THE NEXT REGULAR SESSION

RESOLVED, to adopt the report of the Committee On Laws, Rules and Ordinances Regarding the Proposed Ordinances entitled: "An Ordinance Allowing All Cinemas And Movie Theaters in Batangas City to Add Two Pesos (Php 2.00) Surcharge on All Tickets Sold to Moviegoers As Contribution to the Philippine National Red Cross (PNRC), Batangas Chapter for A Period of Six-Months from May 8 to November 8 Every Year", and "An Ordinance Allowing and Requiring All Cinema Owners and Operators Within the Territorial Jurisdiction of Batangas City To Append in Their Theater Tickets, (Php 2.00) Covering the Period of November 9, 2014 to May 7, 2015 to Support the Operation, Programs and Activities of the Boy Scouts of the Philippines, Batangas City Council", and Scheduling the Same for Second Reading in the Next Regular Session.
