## APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET FOR CALENDAR YEAR 2014 OF BARANGAYS POBLACION 14 AND GULOD LABAC, BOTH OF BATANGAS CITY

WHEREAS, a review of the Supplemental Budget of Barangays Poblacion 14 and Gulod Labac, both of Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991.

**NOW THEREFORE,** be it resolved as it hereby resolves, to approve and declare operative the Supplemental Budgets for the purpose the amount was appropriated:
