RESOLUTION NO. 269 S.2014

**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET
FOR CALENDAR YEAR 2014 OF BARANGAYS POBLACION 14 AND
GULOD LABAC, BOTH OF BATANGAS CITY**

WHEREAS, a review of the Supplemental Budget of Barangays Poblacion 14 and Gulod Labac, both of Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the Supplemental Budgets for the purpose the amount was appropriated:

1. Poblacion 14	P 170,000.00
2. Gulod Labac	P 148,350.00

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.

COMPLIANCE. Compliance to the provisions of the Budget Operations Manual for LGU's issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.

EFFECTIVITY. The approved Supplemental Budget of barangay shall take effect upon approval by the Sangguniang Barangay concerned or on the date fixed in the barangay ordinance as provided in Article 416 IRR and Section 332 LGC.



Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangay, through the Punong Barangay and the City Budget Officer.


