RESOLUTION NO. 108 S. 2015

**A RESOLUTION ADOPTING THE BATANGAS CITY ANNUAL INVESTMENT
PROGRAM SUPPLEMENTAL NO. 1 FOR FISCAL YEAR 2015**

WHEREAS, the Sangguniang Panlungsod duly ensembled in its 27th regular session on October 2014, unanimously approved the Annual Investment Plan for Fiscal Year 2015;

WHEREAS, the City Development Council duly assembled unanimously approved CDC Resolution No. 1 S. 2015 entitled: “Resolution Approving the City Supplemental Annual Investment Program (AIP) No. 1 for Fiscal Year 2015 and Favorably Endorsing it to the Sangguniang Panlungsod for Adoption” on April 7, 2015, embodying the prioritized programs, projects and activities of the City Government of Batangas that is necessary in order to be implemented that will pave way in securing and promoting the general welfare of its inhabitants;

WHEREAS, Supplemental AIP No. 1 is a necessary preliminary undertaking relative to vital priority infrastructure development projects that includes the construction of Calumpang River Third Bridge; rehabilitation of existing grandstand at the Batangas City Sports Complex; completion of the city public market; completion of Colegio ng Lungsod ng Batangas; rehabilitation, improvement, construction of barangay roads and other road components; construction of a new City Engineering Office building; and furnitures, fixtures, furnishings, computers and air-con units for the new building of Colegio ng Lungsod ng Batangas that will all be funded by the loan proceeds from the Land Bank of the Philippines if approved;

WHEREAS, the Sangguniang Panlungsod of Batangas after study and consideration deems that the submitted 2015 Supplemental Annual Investment Program Resolution having been approved by the City Development Council, is in consonance with Sections 106, 109 and 114 of RA 7160 thus constituting valid Supplemental Annual Investment Program to the approved Annual Investment Program for Fiscal Year 2015;
