REGULATORY AUTHORITY (PPP-RA) IN BATANGAS CITY**

WHEREAS, under Section 19-21 of Ordinance No. 3 S. 2013, a Sangguniang Panlungsod member shall sit as member of the Public-Private Partnership Regulatory Authority (PPP-RA) in Batangas City after its creation;

WHEREAS, in a letter dated April 21, 2015, the Honorable City Mayor asked for a recommendation who among the Sangguniang Panlungsod members shall sit thereon as member.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to recommend the Chairman of the Committee on Laws, Rules and Regulations and the Chairman of the Committee on Environment and Urban Development, Land Use and Zoning as members of the PPP-RA in Batangas City.


