RESOLUTION GRANTING THE CITY MAYOR AN AUTHORITY TO ENTER INTO A MEMORANDUM OF AGREEMENT ON MANGROVE PROJECT BETWEEN THE BATANGAS CITY GOVERNMENT AND THE BUREAU OF FISHERIES AND AOUATIC RESOURCES REGION IV-A

WHEREAS, in line with its mandate under R.A. No, 8550 or the 1998 Philippine Fisheries Code as amended by R.A. 10654, BFAR aims to achieve food security to promote sustainable development of fisheries resources and to reduce poverty incidence among fisherfolk and other disadvantaged groups;

WHEREAS, the Government of the Republic of the Philippines through BFAR IV-A in collaboration with the local government concerned is implementing the "Mangrove Reforestation Project" in preparation for the Aquasilviculture Project which aims to ensure resource sustainability, to attain food security and to alleviate poverty to be implemented for the period July 1, 2015 to June 30, 2016.

WHEREAS, Batangas City was chosen as beneficiary of this Mangrove Reforestation Project through the OCVAS Fisheries Division and the project is seen to be vital in improving the aquatic resources of the city as well as its marginalized fisherfolks;

WHEREAS, there is a need to grant authority to the City Mayor to enter into the subject Memorandum of Agreement with the Bureau of Fisheries and Aquatic Resources Region IV-A;

NOW THEREFORE, be it resolved, as it hereby resolves to Grant the City Mayor an authority to enter into a Memorandum of Agreement on Mangrove Project between the Batangas City Government and the Bureau of Fisheries and Aquatic Resources Region IV-A.
