### **COMMENTS / RECOMMENDATIONS:**

On September 29, 2014, Resolution No. 278 S. 2014 was adopted during the regular session held by the members of the Sangguniang Panlungsod of Batangas City, referring the above proposed ordinance to the Joint Committee on Laws, Rules and Regulations and Committee on Barangay Affairs for study, comments and recommendation.

The proposed ordinance is in line with Section 1529 © of the Local Government Code of 1991 (RA 7160) whereas the Barangay may impose a fee for regulation and set conditions on fencing activity/s relating to any construction with or without the need for the application of building or fencing permit from the city.

Finding no legal impediment with the subject, and finding that the proposed ordinance is in consonance with law, the Committee recommends:

- (a) the adoption of this Committee Report and
- (b) approval of the Barangay Ordinance
