
1. To defer the finality of the application that is under study and consideration until such time that all the requirements are complied with.

COMMENTS:

Referred to the Committee on Games and Amusement for study and consideration is the application of Upshot Bingo to be located on ADTRMAM Bldg., G/F National Road, Brgy. Kumintang Ibaba, Batangas City. However, prior to the finality of the said matter, a letter dated February 10, 2016 was received by the committee through the Office of the City Vice Mayor stating the their priority and preferred site was awarded to another bingo operator thus losing the preferred venue. More so, the applicant also requests to grant them with None-Site Specific Resolution.
