APPOINTMENT OF ATTY. NARCISO B. MACARANDANG AS CITY

GOVERNMENT DEPARTMENT HEAD'I (CITY ADMINISTRATOR).

COMMENT / RECOMMENDATIONS:

Section 454 (d) of the Local Government Code of 1991 provides that heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod Members, subject to all civil service laws, rules and regulations.

A scrutiny of the qualifications of Atty. Narciso B. Macarandang shows that he possessed the qualifications and none of the disqualifications for the office for which he is appointed. However, the appointment of Atty. Narciso B. Macarandang as City Administrator is coterminus with the appointing authority as provided for in Section 481 of R.A. 7160.

The function of concurrence is to determine whether the appointee is possessed of all the qualifications and none of the disqualifications as provided by the Code, law or ordinance. Any arbitrary or whimsical withholding of the required concurrence despite the fact that the appointee is qualified, would amount to an encroachment into the prerogative of and discretion of the appointing authority.

In view of the foregoing, the Committee hereby recommends:

- (a) the adoption of the Committee Report
- (b) approval of the resolution hereto attached
