**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS

WHEREAS, a review of the Supplemental Budget of different Barangays of Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991.



SUBMITTED BY : THE COMMITTEE ON APPROPRIATIONS

SUBJECT : SUPPLEMENTAL BUDGETS FOR CALENDAR YEAR 2016 OF DIFFERENT BARANGAYS, ALL OF BATANGAS CITY.

COMMENT / RECOMMENDATIONS:

The supplemental budgets submitted for review contains the necessary documents and action taken by the Office of the City Budget Officer, as follows:

- (1) Certified Statement of Funding Sources, certified by the Brgy. Treasurer (Supplemental Budget Preparation Form No.1).
- (2) Statement of supplemental Appropriation (Objects of Expenditures) – prepared by the Barangay Treasurer and attested by the Punong Barangay (Supplemental Budget Preparation No.2).
- (3) Barangay Appropriation Ordinance approving the Supplemental Budget.
- (4) Letter of the Punong Barangay submitting the budget for review to the Sangguniang Panlungsod.
- (5) Stamped Mark of the preliminary review done by the Office of the City Budget Officer.
- (6) Letter of the City Budget Officer addressed to the SP recommending favorable action on the barangay Budget.

After a review of the said supplemental budgets pursuant to Section 333 of the LGC of 1991 and article 425 of the IRR, the Committee finds the supplemental budgets in accordance with law. Further, the aforementioned Supplemental Budgets of Barangays Poblacion 20, Poblacion 21, Bucal, Cuta, Liponpon Isla Verde, Kumintang Ilaya, Malalim, Malibayo, San Agapito Isla Verde, San Pedro, Soro-soro Ilaya and Dalig, all of Batangas City have passed the preliminary review by the City Budget Office and the same were favorably endorsed by the City Budget Officer.

In view of the foregoing, the Committee hereby recommends:

- (b) approval of the resolution hereto attached
