WHEREAS, Mr. Cecilio Alberto Lazarte applied for the renewal of franchise granting to operate and maintain a Talipapa (Public Market) in Barangay Libjo, Batangas City;

WHEREAS, the Sangguniang Panlungsod enacted Ordinance No. 10, Series of 2010 on October 27, 2010 granting franchise to Mr. Cecilio Alberto Lazarte to operate and maintain a Talipapa in Barangay Libjo, Batangas City.


