COMMITTEE REPORT

SUBMITTED BY : THE COMMITTEE ON LAWS, RULES AND REGULATIONS

SUBJECTS : PROPOSED ORDINANCE ENTITLED "ORDINANCE PROMOTING A DRUG-FREE BATANGAS CITY, PROVIDING SANCTIONS THEREFOR, AND FOR OTHER PURPOSES.

COMMENTS/RECOMMENDATIONS:

Referred to the Committee on Laws, Rules and Regulations is the above entitled ordinance for study, comment and recommendation.

A hearing was conducted on July 26, 2017 by the Committee attended by its members and with the presence of other members of the Sangguniang Panlungsod. Also present was City Administrator Atty. Narciso Macarandang, P.SUPT. Norberto B. Delmas and PSI Glenda R. Cleofe of Batangas City Police Station, Mr. Noel Silang of PESO, Atty. Mikko Paolo A. Perez of DEPED, and representatives from LEIPO Ms. Abigail C. Abendan and Ms. Emmalyn Rose A. Magtibay.

During the committee hearing, the following points were raised:

1. Clarify the definition/meaning of "PROMOTING" used in the title of the Ordinance.
2. ARTICLE I
General Provisions
Section 1-Short Title
Section 2-Declaration of Policies
Section 3-Definition of Terms
3. Definition of Terms: Clarify definition of: employee- to include Job-Order Employee.
4. ARTICLE III
Section 7. Random Drug Test
 - Who will monitor the conduct of drug test in every business establishment?
 - Who will monitor that all employers will declare the actual member of employees in their establishment in order to determine the percentage of employees who went thru random drug testing?
 - Is there a possibility of disclosure of results of the drug testing?

SECTION 13. MONITORING

Suggestion: that employers provide a program for the voluntary, employment-based rehabilitation/clearing of those employees found positive in the drug testing.


