**RESOLUTION NAMING THE EXISTING ACCREDITED BARANGAY HEALTH STATIONS INTO BATANGAS CITY GOVERNMENT/SAN ISIDRO HEALTH CENTER AND BIRTHING FACILITY AND BATANGAS CITY GOVERNMENT/ ILIJAN HEALTH CENTER AND BIRTHING FACILITY**

**WHEREAS**, the Department of Health (DOH) is intensifying its campaign in reducing maternal mortalities in the country, as improvement of maternal health is one of the Millennium Development Goals;

**WHEREAS**, in order to support this thrust of the DOH, the City Health Office have started putting up birthing homes in barangay health stations in some of the barangays of Batangas City.

**WHEREAS**, Barangays San Isidro and Ilijan have been accredited by PhilHealth as facilities providing Maternity Care Package (MCP);

**WHEREAS**, one of the requirements for the issuance of a License to Operate from the DOH is a resolution from the Sangguniang Panlungsod naming these facilities as birthing homes.

**NOW THEREFORE**, be it resolved, as it hereby resolves, to name the existing accredited barangay health stations as birthing facilities.





**SUBJECT :** Letter from the City Mayor, Beverley Rose A. Dimacuha requesting for a passage of a resolution naming the existing accredited barangay health stations into Batangas City Government/San Isidro health center and Birthing Facility and Batangas City Government/Ilijan Health Center and Birthing Facility.

**COMMENTS/ RECOMMENDATION:**

Referred to the Committee on Laws, Rules and Regulations is the above request for study, comment and recommendation.

A letter of the City Mayor dated January 18, 2017 was endorsed to the Sangguniang Panlungsod with the attached letter of Dr. Rosanna Carmelita A. 2. The approval of the required Resolution hereto attached.


