RESOLUTION NO. 349 S. 2017

REQUIRING THE SUBMISSION OF THE JOINT VENTURE AGREEMENT CONCLUDED BETWEEN PRIME WATER AND THE BATANGAS CITY WATER DISTRICT (BCWD)

WHEREAS, Article III Section 7 of Philippine Constitution recognizes peoples right to information on matter of public concern;

WHEREAS, Section 16 of R.A. 7160 otherwise known as the Local Government Code of 1991 states the promotion of the General Welfare;

WHEREAS, Section 25 par. (b) of R.A. 7160, provides that the National Agencies and Offices with project implementation function shall coordinate with one another and with the Local Government Unit concerned in the discharge of these functions.

WHEREAS, during the hearing held at the Sangguniang Panlungsod on November 15, 2017, the representatives of Prime Water and the Batangas City Water District admitted the existence of a concluded Joint Venture Agreement between the parties.

WHEREAS, the representatives of Prime Water and Batangas City Water District were hesitant to produce the copy of the Joint Venture Agreement and to furnish the Sangguniang Panlungsod copy of said contract on ground that the contract is still subject to the approval of the Office of the Government Corporate Counsel (OGCC).

Continuation of Resolution No. 349 S. 2017

REQUIRING THE SUBMISSION OF THE JOINT VENTURE AGREEMENT CONCLUDED BETWEEN PRIME WATER AND THE BATANGAS CITY WATER DISTRICT (BCWD)

WHEREAS, the refusal to immediately furnish us a copy of the agreement violated our constitutional right to information and is preventing the public from studying the Joint Venture Agreement which may be disadvantageous to the government and the water-consumers of Batangas City.

NOW THEREFORE, BE IT RESOLVED AS IT HEREBY RESOLVES by the Sangguniang Panlungsod in session assembled to require Prime Water and the Board of Directors of Batangas City Water District to immediately furnish the Sangguniang Panlungsod of Batangas City the Joint Venture Agreement concluded between the parties.

RESOLVED FURTHER, that upon approval of this resolution all parties concerned be furnished of this Resolution.
