#### **RESOLUTION NO. 374 S. 2017**

RESOLUTION GRANTING THE HONORABLE CITY MAYOR, BEVERLEY ROSE A. DIMACUHA, THE AUTHORITY TO ENTER INTO A CONTRACT TO EXTEND THE 2017 JANITORIAL SERVICES CONTRACT TO AGP SALES AND BUILDING SERVICES, INC. FOR A PERIOD OF THREE (3) MONTHS OR FROM JANUARY 1, 2018 AND UNTIL MARCH 31, 2018

WHEREAS, under the General Welfare Act of the Local Government Code, the City Government is tasked to provide Janitorial Services within and about Batangas City;

WHEREAS, the contract for Janitorial Services has a duration of until December 31, 2017;

WHEREAS, there is a need to extend the existing 2017 Janitorial Services contract of AGP SALES AND BUILDING SERVICES, INC., for at least three (3) months as the Public Bidding for the new contract is yet to be conducted;

WHEREAS, contract extension will serve as an emergency measure to maintain status quo in the janitorial services operations of the City Government;

WHEREAS, AGP SALES AND BUILDING SERVICES, INC., the current service provider, has not violated any of the provisions of the original contract;
