WHEREAS, Republic Act 9994 "An Act Granting Additional Privileges and Benefits to Senior Citizens, Otherwise known as "An Act Maximizing the Contribution of Senior Citizens to Nation Building, Grant Special Privileges and Benefits and for All Other Purposes".
