RESOLUTION NO. 10 S. 2018

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, BEVERLEY ROSE A. DIMACUHA TO RECEIVE DONATION FROM CERES BUS COMPANY OF 1 UNIT BUS FOR THE USE OF THE BATANGAS CITY GOVERNMENT

WHEREAS, on January 8, 2018, a letter of the City Mayor was sent to the Sangguniang Panlungsod requesting for the passage of a resolution granting the City Mayor authority to receive 1 unit of Bus Donation from Ceres Bus Company;

WHEREAS, the said donation is intended for the use of the City Government;

WHEREAS, to serve its intention, the Batangas City Government authorize the Honorable City Mayor, Beverley Rose A. Dimacuha to receive donation from Ceres Bus Company of 1 unit bus. As stated in SECTION 23 AND RULE X ARTICLE 49 of its IRR of R.A. 7160 also known as the Local Government Code of 1991. **AUTHORITY TO NEGOTIATE AND SECURE GRANTS** - Local chief executives may, upon authority of the sanggunian, negotiate and secure financial grants or donations in kind, in support of the basic services or facilities enumerated under Section 17 hereof, from local and foreign assistance agencies without necessity of securing clearance or approval therefore from any department, agency, or office of the National Government or from any higher local government unit: Provided, That projects financed by such grants or assistance with national security implications shall be approved by the national agency concerned: Provided, further, That when such national agency fails to act on the request for approval within thirty (30) days from receipt thereof, the same shall be deemed approved.


