- 1. Strict compliance with the conditions stated in the Evaluation Report of the City Planning and Development Office, as well as with the pertinent provision of RA 9275 (Clean Water Act of 2004).
- 2. The applicant shall construct the wharf in accordance with the modified plan submitted to the City Planning and Development Office/Sangguniang Panlungsod, and shall obtain anew the required ECC and EIS clearances from the DENR of the relocated wharf.
- 3. The applicant shall obtain foreshore lease from the appropriate government agencies.
- 4. Any improvement or additional development to be made within the project site other than those included in this application shall be subject of a separate application for Development Permit.

aforementioned application for zoning/locational clearance for the proposed resort, access road and wharf of Montenegro Shipping Lines, Inc. was indorsed to the Sangguniang Panlungsod by the City Mayor on January 31, 2018 and was referred to the Committee on Environment, Urban Development, Land Use and Zoning during the Regular Session on February 6, A Committee Hearing was held on February 19, 2018. Present are the following: Vice Mayor Emilio Francisco A. Berberabe, Jr., Committee members: Councilors Dela Roca, Cruz, Atienza, Lazarte and other members of the Sangguniang Panlungsod: Councilors Nestor Dimacuha, Macatangay, Aldover and Chavez, City Government Officers: Delia Licarte and Michelle Festijo from CPDO; Gerardo M. Peralta from OCVAS; Charmaine Landicho from City ENRO; and representatives of the applicant: Marlon Q. Capili; Jaime L. Guinto; Jovette Guico; Mark Manuel; Penn Delos Santos and Marivic Maramot. Also in attendance were officials and residents of Barangays Ilijan and Pagkilatan, Batangas City. A follow-up committee hearing was held on May 7, 2018.

#### FINDINGS:

The proposed Resort shall be developed on an area of approximately forty-one thousand two hundred seventy-four (41.274) square meters located along the coastline and boundaries of barangays Pagkilatan and Ilijan. It is approximately twenty (20) kilometers away from the city hall; more or less twelve (12) kilometers away from the Pilipinas Shell Refinery; eighteen (18) kilometers away from SM Shopping Mall, and more or less four (4) kilometers away from Ilijan-KIELCO Natural Gas Power Plant. The proposed project is within the designated ECO-Tourism Development Zone (ETDZ). Based on the submitted plan and project description, the structures, facilities and amenities of the proposed resort include the following:

- Two-storey sixteen (16) rooms/villa hotel building with a total floor area of approximately one thousand a. two hundred sixty-seven (1,267.00) square meters
- Infinity pool with an area of three hundred fifty b. (350) square meters
- Four (4) units nipa hut with an area of sixteen (16) square meters each unit
- Power house (genset house)
- e. Pump room
- f. Parking area with an area of five hundred (500) square meters more or less
- Wharf with an area of 3,760.00 square meters more or
- h. Access road with an area of 768.00 square meters more or less

The Barangay Council of Ilijan passed Resolution allowing Montenegro Shipping Lines, Inc. to construct nipa hut, hotel building and parking area in their property at Sitio Bayanan on June 15, 2017, while the Barangay Council of Pagkilatan passed Resolution stating that they interpose no objection for the establishment of access road, wharf and resort at their property situated in Sitio Ibaba, Pagkilatan, Batangas City.

The proposed wharf was found to occupy a large area which will traverse and probably destroy coral reefs, therefore the applicant is required to alter or modify the wharf plan. applicant agreed to limit the wharf area from the original 120m  $\dot{x}$  30m to 50 x 30 meters or less. The applicant also made a commitment that their construction/project will not destroy or affect the coral reefs in the area.

the wharf plan, Because of the modification of applicant will obtain foreshore lease from the concerned government agencies for the access road from the proposed wharf to the resort.

The wharf, when constructed, may also be used by small sea crafts ferrying from the area to Isla Verde.

Considering the foregoing, the Committee recommends the following:

- 1. To adopt this Committee Report.
- 2. To approve the attached Resolution approving the application subject to the following conditions:
  - Strict compliance with the conditions stated in the Evaluation Report of the City Planning Development Office, as well as with the pertinent provision of RA 9275 (Clean Water Act of 2004).
  - applicant shall construct the accordance with the modified plan submitted to the City Planning and Development Office/Sangguniang Panlungsod, and shall obtain anew the required ECC and EIS clearances from the DENR of the relocated wharf.

- 3. The applicant shall obtain foreshore lease from the appropriate government agencies.
- 4. Any improvement or additional development to be made within the project site other than those included in this application shall be subject of a separate application for Development Permit.

**SUBJECT** 

Application for Zoning/ Locational Clearance for the proposed resort, access road and wharf of Montenegro Shipping Lines, Inc. represented by Mr. Vicente C. Montenegro, Jr. to be located at barangays Pagkilatan and Ilijan, Batangas City

#### A. DESCRIPTION OF PROJECT SITE

The above mentioned properties with a total area of approximately forty-one thousand two hundered seventy-four (41, 274) square meters are located along the coastline and boundaries of barangays Pagkilatan and Ilijan. It is approximately twenty (20) kilometers away from the city hall; more or less twelve (12) kilometers away from the Pilipinas Shell Refinery; eighteen (18) kilometers away from SM Shopping Mall, and more or less four (4) kilometers away from Ilijan – Kielco Natural Gas Power Plant.

The subject properties are as follows with the following description:

Lot No. 16992 pt. situated in Brgy. Ilijan, has a flat topography from the coastline, which becomes rolling to undulating toward Batangas Bay Road. It is planted with coconut trees, shrubs, grasses and few secondary growth trees.

Lot Nos. 16868 pt. and 17001 in Brgy. Pagkilatan has rolling to undulating terrain from the coastline towards the Batangas Bay Road. These two (2) lots were traversed by the Batangas Bay Road planted with grasses, shrubs and few secondary growth trees.

At present, there are no activities being undertaken in the abovesaid properties.

Existing projects/activities located within one (1) kilometer radius from the abovementioned properties are the following:

- 1. Mary the Queen Project 6- storey building with fifty five (55) meter high shrine of Blessed Virgin Mary.
- Sto. Niño Church 2.
- 3. Monte Maria Retreat House
- 4. Diving Camp of Monte Maria
- 5. Isola Vista Beach Resort
- 6. Kamantigue Beach Resort
- 7. Aqua Tanah Merah Beach Resort
- 8. Dream Land Beach Resort
- 9. Vista De Puente Beach Resort
- 10. Jevic Breeze Beach Resort
- 11. Glorymar Vista Beach Resort
- 12. K and Z Pebble Beach Resort

The existing land uses within one (1) kilometer radius from the subject properties are the following:

- 1. residential
- 2. commercial
- 3. institutional
- 4. tourism
- 5. agricultural
- 6. agro forestry

#### **EVALUATION OF FACTS**

- 1. The above-mentioned properties are within the designated Eco - Tourism Development Zone (ETDZ) based on the Batangas City Zoning Ordinance enacted by the Sangguniang Panlungsod under Ordinance No. 1 series of 2015 dated February 9, 2015 and approved by the City Mayor on March 2, 2015 and the Batangas City Comprehensive Land Use Plan for CY 2009 - 2018
- Based on the submitted plan and project description, the structures, facilities and 2. amenities of the proposed resort include the following:
  - a. two-storey sixteen (16) rooms/villa hotel building with a total floor area of approximately one thousand two hundred sixty-seven (1,267.00) square meters
  - b. infinity pool with an area of three hundred fifty (350) square meters
  - c. four (4) units nipa hut with an area of sixteen (16) square meters each unit
  - d. power house (genset house)
  - e. pump room

f. parking area - with an area of five hundred (500) square meters more or less g. wharf – with an area of 3,760.00 square meters more or less h. access road – with an area of 768.00 square meters more or less

- 3. Based on the submitted project description, the wharf will be constructed to accommodate yachts, sail boats and other small vessels that will dock to load and unload supplies and guests coming to and from the resort. The wharf has a total area of three thousand seven hundred sixty (3, 760.00) square meters
- 4. The Barangay Council of Ilijan passed Resolution No. 21 Series of 2017 allowing Montenegro Shipping Lines, Inc. to construct nipa hut, hotel building and parking area in their property at Sitio Bayanan on June 15, 2017.
- 5. The Barangay Council of Pagkilatan passed Resolution No.9 series of 2017 stating that they interpose no objection for the establishment of access road, wharf and resort at their property situated in Sitio Ibaba, Pagkilatan, Batangas City
- 6. The actual uses of the subject properties based on the tax declaration are orchard and horticultural land.
- 7. At present, there are eight (8) existing beach resorts operating along the coastline of barangays Pagkilatan and Ilijan, with average distance of more or less five hundred (500) meters away from the subject properties.
- 8. The EMB-DENR CALABARZON approved and issued an Environmental Compliance Certificate (ECC) for the proposed resort, access road and wharf to be located in barangays Ilijan and Pagkilatan on October 9, 2017.
- 9. The Sangguniang Panlungsod enacted Ordinance No. 26, Series of 2005 otherwise known as "An Ordinance Establishing A Fishery Reserve In the Marine Waters Along the Coastline of Barangay Pagkilatan, Batangas City, Its Utilization, Management, Protection and Conservation." on November 21, 2005.
  - 9.1 The provision of Section 2 of Ordinance No. 26, S. 2005, read as follows to wit:
  - "Section 2. Declaration of Policy It is hereby declared as the policy of the City Government of Batangas to promote fishery conservation, maintain the harvesting capacity of the coastal ecosystem to insure a sustainable production, and to rehabilitate and restore depleted coastal and fishery resources by establishing marine protected areas in areas of high productivity and /or high biodiversity, and furthermore, to conduct research and studies to improve and develop the coastal environment without sacrificing the nature and the fishermen."
  - 9.2 Based on Ordinance No. 26 S. 2005, the total area for Fishery Reserve, which is designated marine protected area where activities are regulated and set aside for educational and research purposes, is seventeen thousand nine hundred (17, 900) square meters.
  - 9.3 The following activities are prohibited per Section 8 of Ordinance No. 26 S. 2005:
    - 1. Except Hook and Line Fishing, all other forms of fishing activities and fishing methods.
    - 2. Conducting activities within the fishing reserve area without proper authorization and permission from the Management Board.

- 3. All prohibitions provided under RA No. 8550 (The Fishery Code of 1998)
- The fishery reserve area in barangay Pagkilatan is approximately one (1) kilometer away from the subject properties.
- 10. The Sangguniang Panlungsod enacted Ordinance No. 13 Series of 2011, otherwise known as "An Ordinance Declaring A Fishery Refuge and Sanctuary In Barangay Ilijan, Batangas City, Its Utilization, Management, Protection and Conservation."
  - 10.1 The provision of Section 8 of Ordinance No. 13 Series of 2011, read as follows to wit:

Section 8. PROHIBITION. No anchorage is allowed on the entire area of the Fishery Refuge and Sanctaury. All watercrafts are required to use the mooring installed for the said purpose.

Within the Core Area of the Fishery Refuge Sanctuary, it is unlawful to:

- 8.1 Conduct any kind or method of fishing activity to catch, take or destroy any fish an other aquatic resources or in any manner disturb, drive away fish fry, fish egg or other type of marine organism.
- 8.2 Enter, short cut or dive through the area with motorized boat or vessel.
- 8.3 Anchor or secure any craft to the sea bottom.

Within the buffer zone the following activities are prohibited:

- 8.4 The use of motorized boat, fishing with scaring devices and or light to attract fish.
- 8.5 Other fishing activities not included in Section of this Ordinance.
- 10.2 Based on Ordinance No. 13 S. 2011, the total area for Fishery Refuge and Sanctuary in barangay Ilijan is sixteen (16.0) hectares, which is composed of Buffer Zone and Core Zone.
- 10.3 The fishery refuge and sanctuary area in barangay Ilijan is more or less three hundred (300) meters away from the subject properties.
- 11. The Batangas City coastal waters, specifically in barangays Pagkilatan, Ilijan, Dela Paz Proper, Dela Paz Pulot Aplaya, and Talahib Pandayan and the whole Verde Island is within the Verde Island Passage which is part of the Sulu Sulawesi Marine Ecosystem (SSME) of about a million (1,003,526) square kilometers hosting the highest marine biodiversity, including coral reefs, mangroves and sea grass ecosystem that support three quarters of the fisheries needs of almost 40 million people.
- 12. The Verde Island Passage is consider "the center of the center" of the world's marine bioderversity due to its significantly high number of species. Scientists from around the world have called for the immediate protection of the Verde Island Passage, which is known as the world's most diverse marine ecosytem, to protect the area from the risk of climate change particularly on its marine species.

13. The Department of Tourism - Southern Tagalog Region, recommended that the entire Verde Island and all areas facing the Verde Island Passage shall be declared as Eco – Tourism Area in the City Land Use Plan and the waters covered by the marine boundaries of the Marine Protected Areas so that marine habitats and species of the Verde Island Passage can be protected through the initiative of the city government.

#### RECOMMENDATIONS:

The application for zoning/locational clearance for the proposed resort, access road and wharf of Montenegro Shipping Lines Inc. through Mr. Vicente C. Montenegro, Jr. to be located at barangays Pagkilatan and Ilijan, Batangas City is being endorsed for appropriate action by the Sangguniang Panglungsod subject to the following conditions:

- 1. The applicable requirements of all concerned government agencies and applicable provisions of the existing relevant laws and city ordinances such as City Ordinance No. 26, series of 2005, otherwise known as "An Ordinance Establishing A Fishery Reserve In the Marine Water Along the Coastline of Barangay Pagkilatan, Batangas City, Its Utilization, Management, Protection and Conservation and City Ordinance No. 13, series of 2011, otherwise known as "An Ordinance Declaring A Fishery Refuge and Sanctuary In Barangay Ilijan, Batangas City, Its Utilization, Management, Protection And Conservation" shall be observed or complied with;
- 2. No expansion, alteration and/or improvement shall be introduced in the project site without prior clearance from the city government;
- 3. Any misrepresentation, false statements or allegations material to the issuance of decisions for the application shall be sufficient grounds or basis for its revocation;
- 4. The proponent shall comply with the provisions of City Ordinance No. 8 Series of 1994, otherwise known as "Providing Priority in Employment or Work to Qualified Barangay Residents".
- 5. The proponent shall comply with all the applicable provision of the Batangas City Environment Code;
- 6. The proponent shall pay all the required taxes and fees to be imposed by the city government;
- 7. The proponent shall secure building permits from the City Engineering Office (CEO) and the Certificate of Zoning Compliance from the City Planning & Development Office (CPDO), for all the buildings and sructures to be constructed within the project site prior to their construction;
- 8. The proponent shall construct slope protection or riprap along the creek at the southern boundary and at the northern boundary of the project site to protect the site from soil erosion and landslides;
- 9. The proponent shall provide 3.0 meters wide easement along the creek at the southern boundary of the project site. No structure or building shall be constructed at the abovesaid easement;
- 10. The proponent shall comply with all the conditions stipulated in the Environmental Compliance Certificate (ECC) from the Environmental Management Bureau (EMB) of the Department of Environment and Natural Resources (DENR) granted to the proposed project on October 9, 2017.

- 11. The proponent shall secure City Environmental Clearance (CEC) from the City Environment and Natural Resources Office (City ENRO) prior to the approval of the proposed projects;
- 12. The proponent shall provide three (3) meters easements along the shoreline of Pagkilatan and Ilijan fronting the project site. No structures/buildings shall be constructed at the abovesaid 3.0 meters easement;
- 13. The proponent shall submit an Engineering and Geological Hazard Assessment Report of the project site approved by the Mines and Geosciences Bureau prior to its approval.
- 14. The proponent shall secure clearance or permit from the concerned Marine Sanctuary Management Board which has jurisdiction over the areas and from the Fishery Division-OCVAS and the Bureau of Fish and Aquatic Resources (BFAR) prior to the approval of the wharf beacuse the site is adjacent to the area declared as a fishery refuge and sanctuary in barangays Pagkilatan and Ilijan to protect and preserve the existing coral reefs and other marine life resources along the coastline of the abovesaib barangays;
- 15. The wharf shall be designed only for docking of small vessels such as yachts, sail boats and motorized boats serving only the resort's guests/clients.
- Only small vessels such as yachts and boats catering to the guests of the resort shall be allowed to anchor at the wharf to protect the existing coral reefs on the coastal waters of barangays Pagkilatan and Ilijan;
- 17. The proponent shall secure foreshore lease permit from the Community Environment and Natural Resources Office (CENRO) of the Department of Environment and Natural Resources (CENRO-DENR) prior to its approval;
- 18. The proponent shall submit to this office a progress report relative to its compliance to the conditions and requirements for the approval of the abovementioned projects;
- 19. The proponent shall allow at any time without prior notice, authorized city government officials/employees to conduct an on-the-spot inspection and monitoring of all on-going activities being undertaken within the project site;
- 20. The transfer of ownership of the project carries with it the responsibility of complying with the abovementioned conditions, the transfer of which shall be made known to this office through a written notification by herein grantee within fifteen (15) days from such transfer.
