WHEREAS, a review of the Supplemental Budgets for Calendar Year 2018 of Barangays Poblacion 5 and Dalig, both from Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budgets for the purpose the amount was appropriated:
