RESOLUTION NO. 210 S. 2018

RESOLUTION URGING NON-GOVERNMENT ORGANIZATIONS AND PEOPLE'S ORGANIZATIONS TO COORDINATE WITH THE LOCAL GOVERNMENT UNIT OF BATANGAS CITY REGARDING THE INSTALLATION OF MARKERS, MEMORIALS MONUMENTS AND OTHER SIMILAR INFRASTRUCTURE, PRESCRIBING THE SPECIFICATION AND STANDARDS THEREFOR AND OTHER PURPOSES

WHEREAS, the State shall safeguard life, health, property and public welfare, consistent with the principles of environmental management and control, and to this end, make it a purpose of this resolution to facilitate the installation and maintenance of markers, memorials, monuments and other similar infrastructure in order to promote the safe and convenient use thereof, pursuant to Book 1, Chapter 2, Section 16 and Chapter 3, Article 1, Section 455, paragraphs (b) (3) (VI) of the Local Government Code;

WHEREAS, there is a need to define, as a matter of policy, a primary reference for the design and installation of markers, memorials, monuments and other similar infrastructure to promote a uniform and consistent standard to maximize public safety and advance the city's aesthetics;

WHEREAS, the Local Government Unit of Batangas City supports Non-Government Organization (NGO's) or People's Organizations (PO's) which are keen on installing markers, memorials, monuments and other similar infrastructure to promote their respective organizations and enhance their public image;

RESOLUTION URGING NON-GOVERNMENT ORGANIZATIONS AND PEOPLE'S ORGANIZATIONS TO COORDINATE WITH THE LOCAL GOVERNMENT UNIT OF BATANGAS CITY REGARDING THE INSTALLATION OF MARKERS, MEMORIALS MONUMENTS AND OTHER SIMILAR INFRASTRUCTURE, PRESCRIBING THE SPECIFICATION AND STANDARDS THEREFOR AND OTHER PURPOSES

WHEREAS, the Local Government Unit of Batangas City deems it necessary for such NGO's and PO's to coordinate their infrastructure projects, especially those which shall be installed in public places, with the government to determine the priority in the location, design and public use, and to ensure conformity to standards and consistency in design;

WHEREAS, the City Engineering Office, as the lead agency to create such primary reference, is better equipped with the mandate of its office, to provide such specification and standards which are more defined, constant and universal;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Panlungsod in session assembled to urge Non-Government Organizations and People's Organizations to coordinate with the Local Government Unit of Batangas City regarding the installation of markers, memorials, monuments and other similar infrastructure;

RESOLVED FURTHER, that the City Engineering Office shall create a list of priority infrastructure projects (such as waiting shed or walkways), and identify the ideal location, which the NGO or PO may consider to incorporate with their marker, memorials, monuments or other similar infrastructure;

RESOLVED FURTHERMORE, that the City Engineering Office shall create a Manual of Standards to be followed by the NGO or PO;

RESOLVED FINALLY, that copies of this resolution shall be forwarded to all existing NGOs and POs operating within the territorial jurisdiction of the City of Batangas and to consider compliance herewith as an additional pre-requisite to the approval for accreditation with the Sangguniang Panlungsod.
