WHEREAS, Section 21 (a) (2) and Section 22 (a) of R.A. 10742 otherwise known as "An Act Establishing Reforms in the Sangguniang Kabataan Creating Enabling Mechanisms for Meaningful Youth Participation in Nation-Building and for Other Purposes prescribes:

- **SECTION 21.** Pederasyon ng Sangguniang Kabataan. (a) There shall be an organization of the Pederasyon ng mga Sangguniang Kabataan to be known as follows:
- 2. In cities, the Panlungsod na Pederasyon ng mga Sangguniang Kabataan which shall be composed of the Sangguniang Kabataan chairperson of barangays in the city; and

SECTION 22. Membership in the Sanggunian and Local Special Bodies. — (a) The duly elected president of the Pederasyon ng Sangguniang Kabataan at all levels, shall serve as ex-officio member of the Sangguniang Bayan, Sangguniang Panlungsod and Sangguniang Panlalawigan, respectively;
