




Teddy Deguito, mam Marissa Serrano from our City Budget, also fron from our City Planning and Development Office mam Maria Clarett Godoy, our City Treasurer mam Nila Olivario, our City Accountant mam Sheryl Bool, so Engr. Sonny you have the floor with regards to the Supplemental Annual Investment Program.

ENGR. GODOY: Thank you very much ho, good morning ho sa ating kagalanggalang Vice Mayor Dr. Jun Berberabe, sa lahat po ng ating members ng Sangguniang Panlungsod, sa aming mga kapwa kasamang mga public servants sa Batangas City Government good morning po sa inyo, naatasan po ako ngayong umagang ito na magpresent ng ating Supplemental Annual Investment Program number 1 for CY 2018. For your information po, ng ating mga kagalanggalang na members ng Sangguniang Panlungsod, this Supplemental Annual Investment Program numer 1 for @018 was adopted by the City Development Council during its full council meeting held on June 26, 2018 at the Teachers Conference Center, Batangas City, nakaattach din po dito yong CDC Resolution No. 1 Series of 2018, adopting approving the said Annual investment program and indorsing it to the Sangguniang Panlungsod

thru the Honorable City Mayor for appropriate action or approval. Referring to the table of contents and to the summary of proposed expenditures indicated in the supplemental AIP alam po naman natin na ang ating Annual Investment Program nahahati sa tatlong bahagi, the Executive General Public Services Sector, the Social Social Services and Economic Services, I'm referring to page 1 nong atin pong summary, so under the General Public Service Sector we have a sub-total of one billion three hundred fifteen million seven hundred fifty five thousand P1,315,755.00, under the Social Services Sector we have sixteen million two hundred thousand 16,200,000.00 and under the Economic Services Center we have three hundred ninety three million two hundred fifty thousand 393,250,000.00 for a total of one billion seven hundred twenty five thousand two hundred five pesos 1,725,205.00, ang highlights po ng ating Supplemental Annual Investment Program dito makikita po natin sa page 3 makikita yong ating mga handling fee for loan use, commitment fee, kasi po ito yong mga loans natin sa Land Bank na katulad ng 3rd bridge, yong public market at saka po yong rehab ng barangay roads improvement ay ito po ay ang mga handling fee na ito originally ay nakakarga po ito sa 20% development fund, but with advice from the City Auditor's Office lahat po ng mga handling fee, commitment fee, other financial services ay dapat ay naka-charge sa general fund, so we come up with the Supplemental Budget po apra maiayos yong pagtsatsargan ng mga fees na ito at ang tangi lang daw pong pwede nating icharge sa 20% development fund with regards don sa mga loan na ito ay yon pong amortization or interest, so yon lang po ang inaallow nila, so apra po maiayos ginawa po nating inilagay dito sa supplemental AIP at ito po ay kasunod nito ay ang paggagawa naman sng Supplemental Budget na basehan nito, iba pa pong mga expenses na nakasama dito yon pong mga request ng DepEd na hindi po nakasama don sa ating regular AIP, itong ating regular AIP for 2018, other proposed project po under the disaster na popondohan ng ating CDRRMF Fund at saka po yong under the Office of the City Mayor, mapapansin din po ninyo yong ating sa PS, nakasama po dito yon, ito po kasi yong pinopropose na kung sakali ay maereceive ng ating mga kasamahan, as a benefit don sa ating Performance don sa PBB, kung sakali po. Isinama na po namin dito yon at para po kung

sakaling magkaron ng Supplemental Budget ay nakabase na pong lahat sa ating Annual Investment Program, thank you very much po.

KAG. VILLENA: Nabanggit po ninyo yong PBB ay talagang yan ho yata ay iniintay na ng mga empleyado at yan yata ay supposed to be dapat ay nong February pa, totoo ga ho yon, kaya nga lang ay hindi yata naiisaayos pa dahil hindi yata malaman kung magkano ga kaya talaga ang tatanggapin ng bawat isang empleyado, so nakaincorporate din pala rito yon.

Godoy, sa page 4 po, don po sa purchase of airconditioning units for the Batangas City Coliseum, Batangas City Convention Center and Teachers Conference Center po, non pong November of 2017 ang amin pong Records Officer si mam Meldy po ay sumulat na po kay Mayor Beverly para makahingilang po kami ng split type na airconditioning sa amin pong Records Section, dahil wala po siyang aircon ngayon, yong mga records po natin ay mainit yong kwarto namamawis pag natuyo po ay lumulutong po yong mga papel, ay napakaimportante po nitong aming records section at nadiyan po ang mga vital documents natin, tapos sumulat uli po kami nong February 2018, June 11 of 2018, lumalambing lang po kami baka naman po pwedeng isama ang isang split type airconditioning para sa Records section namin kasi napakaimportante po ito sa aming division kasi sayang naman po yong ating mga papers don kung masisira lang ay wala naman po kaming ibang pamamaraan kung paano ipipreserve itong mga dokumentong ito, baka pupwede namang makalambing ng isang split type airconditioning, kasama na rin naman po ito sa Supplemental Budget na inilagay namin for 2018 number 1 ay baka namn po maisasama natin dito sa Supplemental AIP Budget, ang isang split type airconditioning para sa Sangguniang Panlungsod sa Records Section.


ENGR. GODOY: Mr. Chairman, with regards po don sa info from our honorable Vice Mayor andito naman po yong other members ng Local Finance Committee, at I think they are all aware kung ito po ay nasa ating regular AIP or sa inapruban natin last time so baka po sakaling ito ay meron silang magiging kasagutan o katugunan kung ito ay nakasama don sa ating mga ____.

VM. BERBERABE: Hindi yata po siya nakasama don sa regular AIP kasi parang pinangakuan lang ang aming Records Division officer na sige kami na lang ang bahala diyan kasi capital outlay natin ay lahat ay nasa Mayor's Office po, nakapagsabi na rin naman po sila kay Mayor baka lang po nakakalimutan ay napakaimportante po nito, pangalawa po, yon pong purchase of various vehicles for the use of the City Government kasi po yong aming request yata ng Sangguniang Panlungsod na mga para sa ating mga City Councilors, hindi po namin alam kung ito po ba ay nadiyan na, ibibigay na yong tatlong vehicles na yon or magrerequest pa po ang iba naming mga kasamahan, ng panggamit po nila, alam naman po nyo public servant ay 24 hours a day na kailangan nila ang sasakyan, pakilinaw lang po yong various vehicles for the use of the City Government, kasama po ba diyan ang sa Sangguniang Panlungsod yong request nila?

Chair: With regards to the query of our Honorable Vice mayor regarding the vehicles that we approved nung mga nakaraang araw po ano, yun po ay nasa DILG na po at we are coordinating with our GSD ma'am Joyce Cantre, medyo nagte-take lang po ng time dun po sa ahensya bago po ibaba.

VM Dr. Jun Berberabe: So yun po yung tatlong (3) vehicles lang, 3 sasakyan.

Chair: Yun pong ni-request po natin dati okay na po yun for approval na lang po.

VM Dr. Jun Berberabe: Ah, salamat.

Chair: We would like to acknowledge the presence of our Councilor Hamilton Blanco and we would like also to acknowledge the presence of Councilor Armando Lazarte. Councilor Hamilton.

Coun. Hamilton Blanco: Thank you Mr. Chair, sa atin pong mga bisita good morning, sa tunay po yun din ang aking itatanong eh, kung ano ga po talagang linaw na dun po sa 3 vehicle na amin pong nire-request dito. Dati nga po last year. Last quarter of 2017 yun nga po yung ating... nasabi ninyo na ginintuang pangarap at ito nga po ay kasama yun pong mga ilang vehicle na nilalambing nga po ng Sangguniang Panlungsod dahil ika nga ho dito ay 3 na yung pa-graduating kakaunti na hong buwan, wala na hong isang taon ay kami ho'y mawawala na rito at ika nga'y tatagso na. Anyway, meron po pala namang kasagutan ang GSD tungkol po dito na sana nga po malinawan kami pahinggil nga po dun sa aming nire-request na yun. Ang sa akin laang ho Mr. Chairman, napakaganda ho nito, itong page 4 dun po sa una, purchase of air conditioning units of Batangas City Coliseum, napakaganda ho niyan kung mai-itupad ho natin na malagyan yan kasi nagdaraos ho tayo ng iba't-ibang event dito at sa tunay ho isang example na lamang ay ang Maharlika na basketball na ginanap po hindi

laang po sa Luzon bagkus ay buong Pilipinas na iyan. 2016, 25 game per team natural na dadayo't-dadayo rito ang iba't-ibang mga lungsod sa buong Pilipinas na sana naman po ay maging presentable rin nga tayo sa pagho-host po ng mg ganitong event na hindi lang ho sa katunayan dun lang yan magagamit bagkus pagka ho tayo ay may mga event na Foundation, Batangas City Day, Ms. Batangas, napakarami pong iba kasi kitang-kita naman po natin ahh sa mga manonood, maging ako nakakaranas na talagang kung hindi kayo magdala ng pamaypay diyan ay talagang hindi ho talaga sasapat ang lamig bagus ay meron na po tayong nakalagay dyan at nakatalagang mga aircon pero kung ho yun sa tingin ko. Kung makakapunta po tayo ng ibang lungsod, Sta. Rosa napakaganda po ng facility diyan kulang na nga lamang ay jacket pero dito sa atin sana nga po magkaroon niyan. But anyway, naitanong na naman po Mr. Chairman ni vice mayor ang purchase of vehicles yun lang po talaga ang itatanong ko, maraming salamat at magandang umaga pong muli.

Chair: Thank you Konsehal Hamilton Blanco, are there any other queries? The chair has no other questions since magkasama po kami ni Engr. Sonny dun po sa ating City Development Council so, I'm aware of all the inclusions in Supplemental AIP. Councilor Karlos Buted.

Coun. Karlos Buted: Thank you Mr. Chair, good morning po sa inyong lahat. First of all I would like to thank you for joining us here today, ano po thank you po sa invitation. Now, kay Mr. Sonny po, actually I'm not sure if I understand it correctly yung sinabi nyo po kanina nao po, help me understand po yung nabanggit nyo po kanina na parang dito po sa handling paper loan use yung construction of Calumpang 3rd Bridge, completion of City Market and etc., ano po, I believe that we are all aware na yun pong construction sa City Public Market is came from the loan po ng sa Land Bank. Ano po yun, nagkulang po ba yung loan kasi di ba nag-appropriate na po ang Sangguniang Panlungsod para po doon sa construction and then parang may nabanggit po kayo kanina na kailangan po na sa General Fund kukunin, okay po, just ano lang po clarification, oho. Thank you Mr. Chair.

Engr. Sonny Godoy: Mr. Chairman permission to answer.

Chair: Engineer Sonny and then Councilor Hamilton.

Engr. Sonny Godoy: With regards po dun sa clarification ni Honorable Councilor Buted, ang nakalagay po dito ay yun pong financial expenses na involve po dun sa loan, yun pong handling fee, commitment fee and yun pong documentary stamps. Yun po yung mga... ah inilipat lang po yung charges na instead originally ay nasa 20% development fund ay ilalagay lang po sa general fund. Hindi po nagkulang yung pondo sa Land Bank, yung loan natin ito po yung mga kaakibat laang na mga expenses for documentation sa paglo-loan natin. Kasi ang ina-allowed lang po ng COA at ayon po sa batas ay yun pong amortization lang at saka interest ang pwedeng i-charge sa 20%. Kasi po itong mga development projects na katulad ng bridge, ito pong ating market at saka itong mga karsada, ito po'y under nang... pwede sa 20% development fund, so yun lang po yung mga financial services, thank you po.

Coun. Karlos Buted: Thank you po, thank you Mr. Chair.

Chair: Thank you Councilor Buted, Councilor Blanco.

Coun. Hamilton Blanco: Thank you again Mr. Chair, to Engr. Sonny Godoy po, page 5 po sir, sir gusto ko lang ho sir malinawan dito po sa ATM ID health card EBD beneficiaries. Baka po naman pwede nyo kaming bigyan ng background kung ano po talaga ito, ilan ga po talaga ang beneficiaries natin nang EBD at papaano po ito, thank you.

Chair: Yes Engr. Sonny.

Engr. Sonny Godoy: With regards po dun sa sa project na ito, ATM ID Health Card, ito po yung production and procurement ng ID na health card para po dun sa mga EBD beneficiaries, with regards to the number wala po akong figure dahil ito po ay manggagaling sa City Health kung ilan yung beneficiaries po natin, sya po yung bibigyan nitong ATM, parang design na ID Health Card.

Coun. Hamilton Blanco: Ibig po nyong sabihin engineer pag sinabi pong ATM may makukuha po silang pera dun or yun pong card na yun eh, kagaya ng dati na ipe-present po natin sa isang ospital na dun po ide-deduct yun, ano po ang ibig sabihin?

Engr. Sonny Godoy: Ahh, siguro po'y hihingi ako ng paglilinaw mula dun sa mga financial expert na kasama ko sa local finance kasi po yung sa regards dun sa... na baka

meron kayong description with regards dun sa proposal na ito ng City Health.

Chair: Any body from the members of Local Finance Committee?
