

**COMMITTEE REPORT**

**SUBJECT: PROPOSED ESTABLISHMENT OF STAND-ALONE SENIOR HIGH SCHOOL IN MAHABANG DAHILIG, ELEMENTARY SCHOOL.**

The subject request for a resolution in favor of establishing Stand-Alone Senior High School was referred to the Committee on Education for its consideration during the Regular Session on June 5, 2018. The Committee held a hearing on June 26, 2018 and in attendance were the following:

From DepEd: Mr. Herman A. Catapang; From Mahabang Dahilig Elementary School: Mrs. Evelyn E. Delos Reyes. Also present are the Chairman Coun. Alyssa Renee A. Cruz and Committee members Coun. Karlos A. Buted; Coun. Armando C. Lazarte, Councilors Glenn M. Aldover and Coun. Sergie Rex M. Atienza, Vice Mayor Emilio Francisco Berberabe and Councilors Gerardo A. Dela Roca, Julian B. Villena, Hamilton G. Blanco, Nestor Dimacuha and Nelson Chavez.

**COMMENTS:**

During the committee hearing, the Education Program Supervisor in-charge of Senior High School mentioned about the DepEd Order No. 51, S. 2015 stating the Establishment of Stand-Alone Public Senior High Schools (SHS) and Conversion of Existing Public Elementary School into Stand-Alone Senior High Schools.

The proposed establishment of Stand-Alone SHS is due to the reforms brought about by the K-12 curriculum, as the Mahabang Dahilig Elementary School has the capability of offering the said program.
