**WHEREAS**, according to Rule 2 Section 2 of Republic Act 10121 “An Act Strengthening the Philippine Disaster Risk Reduction and Management System Providing for the National Disaster Risk Reduction and Management Framework and Institutionalizing the National Disaster Risk Reduction and Management Plan, Appropriating Funds Therefore and for Other Purposes”, the City Disaster Risk Reduction and Management Council is mandated to facilitate and support risk assessments and contingency planning activities at the local level;

**WHEREAS**, it has been drafted in accordance with the national, regional and provincial framework and policies on disaster risk reduction in close coordination with the city development council;

**WHEREAS**, the City Disaster Risk Reduction and Management Council, gathered data, conducted meetings and workshops, and drafted a Contingency Plan for Worst Case Scenario of Typhoon for the City of Batangas;

**NOW THEREFORE**, be it resolved as it hereby resolves by the Sangguniang Panlungsod in session assembled to approve and implement the Contingency Plan for the Worst Case Scenario of Typhoon of the City of Batangas.





### COMMITTEE REPORT

**TO: THE HONORABLE SANGGUNIANG PANLUNGSOD**  
**FROM: THE COMMITTEE ON LAWS, RULES AND REGULATIONS**  
**SUBJECT: CONTINGENCY PLAN FOR WORST CASE SCENARIO OF**  
**TYPHOON OF THE CITY OF BATANGAS**

The subject request for approval and implementation of the Contingency Plan for Worst Case Scenario of Typhoon of the City of Batangas was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on April 10, 2018. The Committee held a hearing on August 7, 2018 and in attendance were the following:

From the Office of the City Disaster Risk Reduction and Management: Mr. Rodrigo Dela Roca; representative from CPDO: Mr. Jonadel Crispin A. Licarte; from CSWDO: Mrs. Mila Española; and representative from CEO: Engr. Gemma D. Nuñez. Also present are the Chairman Coun. Alyssa Renee A. Cruz and Committee members Coun. Sergie Rex M. Atienza, Coun. Armando Iazarte and Coun. Julian B. Villena, the Vice Mayor Emilio Francisco Berberabe Jr, and other members of the Sangguniang Panlungsod Councilors Hamilton Blanco, Oliver Macatangay, Karlos Buted, Nestor Dimacuha, Nelson Chavez, and SK Federation President Marjorie A. Manalo.

#### **FINDINGS:**

During the committee hearing, the City Disaster Risk Reduction and Management Officer made an introductory statement regarding the proposed Contingency Plan of Batangas City. He stated that this proposed Contingency Plan is a response plan which is a requirement and is aligned to the template provided by the National Risk Reduction and Management Council.

Likewise, further information about each Chapters of the proposed plan were introduced by the CDRRM Officer like the Introduction of the Contingency Plan as disclosed in Chapter I; the Goals and Objectives of the Plan in Chapter II; and The Command and Control or the clustering of various agencies who will be responsible for disaster response in Chapter III.

Some of the concerns of the Committee members were cited during the hearing. One of these is the plan to evacuate Senior Citizens and other those who are vulnerable.

This concern was answered by the CDRRM Officer stating that the one who should take charge of this activity is the Committee Chairperson for Disaster headed by the City Social Welfare and development Officer of Batangas City. Another concern from the members of the Sangguniang Panlungsod are the capability and capacity of the barangay during disaster, the budget allocation of materials and other resources needed at the barangay level intended for disaster response, the awareness, preparedness and readiness of people through education, the clustering of various committee to render various services related to disaster, and separate data or other contingency plan for worst case scenario of earthquake in Batangas City.

In addition to this, the CDRRM Officer also disclosed the plan of the City Government to construct a Command Center that will facilitate all the activities related to disaster response and mitigation. It was also reiterated that the CDRRM Council are reviewing to include in the 2019 Budget the resources and materials needed by each barangays for them to be readily equipped and can respond quickly in times of disaster.

Finally, the Contingency plan in times of earthquake and human-caused emergencies should follow after this approval.

### RECOMMENDATIONS:

In view of the foregoing, the Committee hereby recommends:

1. The approval and implementation of the Contingency Plan for Worst Case Scenario of Typhoon of the City of Batangas through a resolution attached hereto.
2. The adoption of this Committee Report.
