RESOLUTION NO. 248 S. 2018

RESOLUTION DECLARING EVERY AUGUST 12-19 OF EVERY YEAR AS LINGGO NG KABATAAN IN THE CITY OF BATANGAS

WHEREAS, Republic Act 10742 known as the Sangguniang Kabataan Reform Act of 2015 declares that the State recognizes the vital role of the youth in nation-building and thus, promotes and protects their physical, moral, spiritual, intellectual, and social well-being, inculcates in them patriotism, nationalism, and other desirable values, and encourages their involvement in public and civil affairs.

WHEREAS, the State shall establish adequate, effective, responsive, and enabling mechanisms and support system that will ensure the meaning participation of the youth in local governance and in nation-building.

WHEREAS, Section 30 (a) (b) of R.A. 10742 otherwise known as An Act Establishing Reforms in the Sangguniang Kabataan Creating Enabling Mechanisms for Meaningful Youth Participation in Nation-Building and for Other Purposes provides:

a) Every barangay, municipality, city and province shall conduct an annual activity to be known as the Linggo ng Kabataan on the week where the 12th of August falls to coincide with the International Youth Day. The Sangguniang Kabataan, in the case of barangay and the respective LYDC in cooperation with the Pederasyon ng mga Sangguniang Kabataan, in the case of municipality, city and province, shall take the lead in this observance.

Continuation of Resolution No. 248 S. 2018

RESOLUTION DECLARING EVERY AUGUST 12-19 OF EVERY YEAR AS LINGGO NG KABATAAN IN THE CITY OF BATANGAS

b) The observance of the Linggo ng Kabataan shall include the election of the counterparts of all local elective and appointive officials, as well as heads of national offices or agencies stationed or assigned in the territorial jurisdiction of the local government unit, among in-school and community youth residing in the local government concerned from ages thirteen (13) to seventeen (17). During said week, they shall hold office as boy and girl officials and shall perform such duties and conduct such activities as may be provided in the ordinance enacted pursuant to this Chapter.

NOW THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Panlungsod in session assembled to declare August 12-19 of every year as the celebration of the Linggo ng Kabataan in the City of Batangas.

RESOLVED FURTHER, that copies of this resolution be forwarded to the City Mayor Beverley Rose A. Dimacuha, Congressman Marvey Mariño, all Departments, Agencies of Local Government of Batangas City, Schools and Universities in Batangas City including SK of every barangay of Batangas City.
