**APPROVING ON FIRST READING AND REFERRING TO THE COMMITTEE ON  
LAWS, RULES AND REGULATIONS THE PROPOSED ORDINANCE REQUIRING  
ELECTRIC POWER DISTRIBUTORS, TELECOMMUNICATION COMPANIES,  
CABLE TELEVISION SERVICE PROVIDERS AND OTHER SIMILAR UTILITY  
COMPANIES TO RELOCATE THEIR SERVICE POLES FROM HIGHWAYS,  
NATIONAL ROADS AND MAJOR THOROUGHFARES WITHIN THE TERRITORIAL  
JURISDICTION OF BATANGAS CITY**

**RESOLVED**, to approve on First Reading the proposed ordinance entitled: “An Act Requiring Electric Power Distributors, Telecommunication Companies, Cable Television Service Providers and Other Similar Utility Companies to Relocate their Service Poles from Highways, National Roads and Major Thoroughfares Within the Territorial Jurisdiction of Batangas City.

**RESOLVED FURTHER**, to refer the aforementioned proposed ordinance to the Committee on Laws, Rules and Regulations for further study, comments and recommendations.


