SUBJECT: PROPOSED ESTABLISHMENT OF INTEGRATED SENIOR HIGH SCHOOL IN BATANGAS NATIONAL HIGH SCHOOL.

The subject request for a resolution in favor of establishing Integrated Senior High School was referred to the Committee on Education for its consideration during the Regular Session on September 25, 2018. The Committee held a hearing on October 3, 2018 and in attendance were the following:

From Batangas National High School: Mrs. Lorna Ochoa, Mrs. Editha A. Ramos and Mrs. Sofia D. Montalbo. Also present are the Chairman Coun. Alyssa Renee A. Cruz and Committee members Coun. Sergie Rex M. Atienza, Coun. Glenn M. Aldover, Coun. Armando C. Lazarte, Coun. Oliver Macatangay and Coun. Marjorie A. Manalo, and other members of the Sangguniang Panlungsod Councilors Nestor Dimacuha and Nelson Chavez.

COMMENTS:

During the committee hearing, the Senior High School Coordinator of San Agapito National High School mentioned about the DepEd Order No. 51, S. 2015 stating the Establishment of Integrated Senior High Schools (SHS). The proposed establishment of San Agapito Integrated SHS is due to the reforms brought about by the K-12 curriculum, as the above-cited School has the capability of offering the said program.

The Committee and the rest of the members of the Sangguniang Panlungsod have no question on this request given that this establishment of an Integrated Senior High School would be beneficial to the City Government most particularly to its constituents. They further reiterated their support on this endeavor as long as this would create welfare and future for all of our Batangueño students.
