RESOLUTION NO. 394 S. 2018

RESOLUTION GRANTING THE HONORABLE CITY MAYOR BEVERLEY ROSE A. DIMACUHA, THE AUTHORITY TO ENTER INTO A CONTRACT TO EXTEND THE 2018 CONTRACTS TO RBC PETRON GASOLINE STATION, AGP SALES AND BUILDING SERVICES INC., METROWASTE SOLID WASTE MANAGEMENT CORP., AND WORLD CUP SECURITY SERVICES INC. FOR A PERIOD OF THREE (3) MONTHS OR FROM JANUARY 1, 2019 AND UNTIL MARCH 31, 2019

WHEREAS, under the General Welfare Act of the Local Government Code, the City Government is tasked to maintain status quo in the operation of their service vehicles and provide Janitorial Services, garbage collection, hauling and disposal services and an operational Sanitary Landfill and Security Services within and about Batangas City;

WHEREAS, the contracts for supply and delivery of fuel, oil & lubricants, janitorial services, garbage collection, hauling and disposal services and security services has a duration of until December 31, 2018.

WHEREAS, there is a need to extend the existing 2018 contracts to RBC Petron Gasoline Station, AGP Sales and Building Services Inc., Metrowaste Solid Waste Management Corp., and World Cup Security Services Inc. for at least three (3) months as the Public Bidding for the new contract is yet to be conducted;

WHEREAS, the contract extensions will serve as an emergency measure to maintain status quo in the operation of service vehicle of the City Government, janitorial services operations, security operations specifically in guarding and protecting the City Government's personnel, premises and properties from theft, pilferage, burglary, robbery, arson, vandalism, trespass and other criminal and unlawful acts and to avoid service disruption;

WHEREAS, RBC Petron Gasoline Station, AGP Sales and Building Services Inc., Metrowaste Solid Waste Management Corp., and World Cup Security Services Inc., the current service providers, have not violated any of the provisions of the original contract;

WHEREAS, this extension will not change or modify the terms and conditions of the original contract, except when changes or modifications will redound to the advantage of the government and no additional cost to the City Government.

NOW THEREFORE, be it resolved, as it hereby resolves, to grant authority to Honorable City Mayor, Beverley Rose A. Dimacuha to enter into a contract to extend the 2018 contracts to RBC Petron Gasoline Station, AGP Sales and Building Services Inc., Metrowaste Solid Waste Management Corp., and World Cup Security Services Inc. for a period of three (3) months or from January 1, 2019 and until March 31, 2019;

RESOLVED FURTHER, that copies of this resolution be forwarded to the offices concerned for their information and reference.

COMMITTEE REPORT

SUBJECT: RESOLUTION EXTENDING THE 2018 CONTRACTS OF RBC
PETRON, AGP SALES AND BUILDING SERVICES INC.,
METROWASTE SOLID WASTE MANAGEMENT CORP. AND
WORLD CUP SECURITY SERVICES INC.

The subject request for the passage of a resolution was referred to the Committee of the Whole chaired by the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on November 19, 2018. The Committee held a hearing on December 3, 2018 and in attendance were the following:

From General Services Department: Ms. Joyce Cantre; from the Office of the City ENRO: Mr. Oliver Gonzales; from RBC Petron: Mrs. Arlene Magadia; from Metrowaste: Mr. Oliver Salas, Mr. Leo Tadeffa and Mrs. Menchu Bochsler and from World Cup Security Services Inc.: Atty. Romulo Mahor, Mr. Rudy Cariaga and Mr. Rustico P. Morelos. Also present are the Chairperson Coun. Alyssa Renee Cruz and Committee members Coun. Sergie Rex M. Atienza, Coun. Julian B. Villena, and Councilor Gerardo Dela Roca and other members of the Sangguniang Panlungsod Councilors Karlos Buted and Julian Pedro Pastor.

FINDINGS:

During the committee hearing, the Batangas City General Services Officer made an introductory statement about the requests stating that as per the Revised Guidelines on the Extension of Contracts for General Support Services, it is necessary to support the operations of any of the procuring entities or for the enhancement of the welfare of its personnel to include, but shall not be limited to, non-personal or contractual services such as maintenance of equipment and furniture, janitorial and security services. It was also mentioned that under general conditions for extensions, no contract extension shall exceed one (1) year.

There are points raised by the members of the Committee regarding the requirements of basic gears for those people/employees who collecting the waste for their

additional protection. It was also reiterated the concern of educating them about their company mandates in order to perform effectively their duties and responsibilities.

Other concerns raised was the expansion of services of garbage collection on areas like Tabangao, Pinamucan, Simlong, Mabacong and Pagkilatan since they are also contributing to the growth of Batangas City because of various industries located on their vicinities and also to better ensure the effectiveness of those service sectors.

RECOMMENDATIONS:
