RESOLUTION APPROVING THE CITY DISASTER RISK REDUCTION AND
MANAGEMENT TRUST FUND PLAN AND PROGRAM FOR 2018 IN THE TOTAL
AMOUNT OF FOUR HUNDRED NINETY THOUSAND PESOS (P490,000.00)

WHEREAS, Section 336 of the Local Government Code of 1991 states:

Section 336. Use of Appropriated Funds and Savings. Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. **However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance,** be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the **same expense class** of their respective appropriations.

NOW THEREFORE, BE IT RESOLVED as it is hereby resolved, by the Sangguniang Panlungsod in session assembled to approve the City Disaster Risk Reduction and Management Trust Fund Plan and Program for 2018 in the total amount of Four Hundred Ninety Thousand Pesos (P490,000.00).

RESOLVED FURTHER, that the copy of this resolution be forwarded to the Office of the City Mayor for immediate action.
