**A RESOLUTION ADOPTING THE CITY ACTION PLAN FOR THE  
PANTAWID PAMILYANG PILIPINO PROGRAM AND ITS INTEGRATION IN  
THE ANNUAL INVESTMENT PLAN AND EXECUTIVE LEGISLATIVE  
AGENDA OF THE CITY OF BATANGAS**

**WHEREAS**, the Pantawid Pamilyang Pilipino Program cannot address the various facets of poverty and needs collective and joint effort to battle its intergenerational cycle in the City of Batangas;

**WHEREAS**, a unified plan is important to identify interventions from the local level for the benefit of the Pantawid Pamilya beneficiaries in the City of Batangas;

**WHEREAS**, a City Action Plan will reflect complementation mechanisms of existing intervention of different participating partners and projects in the City of Batangas;

**WHEREAS**, the adoption of a City Action Plan, through its integration in the Annual Investment Plan and the Executive Legislative Agenda will effectively address the causes of poverty experienced by the local stakeholders in the City of Batangas;

**WHEREAS**, the City Action Plan is vital to ensure that local beneficiaries of the Pantawid Pamilyang Pilipino Program in the City of Batangas who have reached subsistence and self-sufficiency levels of well-being will no longer be back to their previous status and condition;


