LETTER FROM THE CITY MAYOR BEVERLEY ROSE A. DIMACUHA REQUESTING FOR THE PASSAGE OF ORDINANCES FOR APPROPRIATIONS OF FUND IN THE COLEGIO NG

LUNGSOD NG BATANGAS.

COMMENTS:

The subject request for the passage of an ordinance for appropriations of fund in the Colegio ng Lungsod ng Batangas (CLB) was referred to the Committee on Appropriations for its consideration during the Regular Session on July 9, 2019. The Committee held a hearing on July 11, 2019 and in attendance were the following:

From City Planning and Development Office: Engr. Januario B. Godoy; from Colegio ng Lungsod ng Batangas: Dr. Lorna L. Gappi, Mr. Andrew Brian Deguito, Mr. Doringer P. Cabrera, Mr. Mark Macarandang, from City Treasurer's Office: Mrs. Nila Petronila R. Olivario; from City Accounting Office: Mrs. Sherryl B. Bool; from City Budget Office: Mrs. Elizabeth Q. Delos Reyes and some of the Sangguniang Panlungsod employees. Also present are the Chairperson Coun. Alyssa Renee A. Cruz and Committee members Coun. Julian B. Villena, Coun. Gerardo A. Dela Roca, Coun. Nelson Chavez, and Coun. Oliver Macatangay, the Vice Mayor Emilio Francisco A. Berberabe Jr., and other members of the Sangguniang Panlungsod Councilors Nestor Dimacuha, Karlos Buted, Julian Pedro M. Pastor Coun. Isidra M. Atienza, Coun. Maria Aleth Lazarte, Coun. Lorenzo A. Gamboa Jr., and SK Federation President Marjorie A. Manalo.

During the committee hearing, it was presented by the College Administrator of the Colegio ng Lungsod ng Batangas the intention of the institution for the passage of ordinances in relation to the current status of the Commission on Higher Education (CHED) specifically the Unified Student Financial Assistance System for Tertiary Education (UniFAST) Fund. She also reiterated that it was agreed upon that the amount of Free Higher Education shall be transferred from CLB Trust Fund to CLB Current Account (GF).

In connection to the first request specifically An Ordinance for the Appropriation of P3,892,724.20 (1st Semester AY 2018-2019) from CHED-UniFAST to the Supplemental Budget of Colegio ng Lungsod ng Batangas, the committee recommends that this should undergo proper local budget procedure the same should first be incorporated to the Supplemental Budget through the recommendation of the Local Finance Committee (LFC).

On the other hand, the request for an Ordinance for the Authority Given to the City Treasurer, to Transfer All Succeeding Free Higher Education (FHE) Fund from CLB Trust Fund to CLB Current Account (GF) was approved, however, it was suggested that it should be in form of Resolution and not an Ordinance and the proper signatories include the City Mayor, City Treasurer/OIC City Treasurer and OIC City Accountant to transfer all fund from Land Bank CLB Trust Fund to Land Bank CLB Current Account (GF).

RECOMMENDATIONS:

With the view that this request will eventually be favorable to the fiscal status of its City of Batangas, the Sangguniang Panlungsod perceives the essentiality to pass or approve the said resolution.
