COMMITTEE REPORT

SUBJECT: AN ORDINANCE REGULATING THE ESTABLISHMENT OF APARTMENT AND ALL BOARDING HOUSES IN BARANGAY TABANGO APLAYA, BATANGAS CITY, PRESCRIBING PENALTIES FOR VIOLATIONS HEREOF, AND FOR OTHER PURPOSES

COMMENTS/RECOMMENDATIONS:

Referred to the Committee on barangay affairs for further study, comments and recommendations.

Section 16 chapter 2 of R.A. 7160 under its General Welfare clause states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

Said ordinance aims to promote the welfare of the barangay residents by promoting peace and order as well as public safety of the residents and inhabitants in the regulation of boarding houses and apartments. The prescribed penalties for violation of the same ordinance also falls within the limits as prescribed in the Local Government Code.

Finding no legal impediment and having shown its good intention to implement the subject ordinance, the committee hereby recommends:

- 2) Approval of the Barangay Ordinance
