**RESOLUTION REQUESTING THE CITY ENGINEERING OFFICE TO
FACILITATE THE DISPOSAL, CLEARING AND CLEANING OF ALL
AREAS UNDER CONSTRUCTION IN BATANGAS CITY PROPER**

WHEREAS, Art I, Sec. 15 of the constitution of the Republic of the Philippines states that it is the policy of the nation to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, chapter II Sec. 1101 paragraph (a) of PD 1096 otherwise known as National Building Code of the Philippines provides that x x x no person shall use or occupy a street, alley or public sidewalk for the performance of work x x x

WHEREAS, Sec. 16 of RA 7160 provides that every local government unit shall promote health and safety of the people;

WHEREAS, construction and discarded materials stored along the portion of the road not only pose imminent danger to general public using the road but likewise suppress the flow of traffic.




