WHEREAS, chapter II Sec. 1101 paragraph (a) of PD 1096 otherwise known as National Building Code of the Philippines provides that x x x no person shall use or occupy a street, alley or public sidewalk for the performance of work x x x

WHEREAS, Sec. 16 of RA 7160 provides that every local government unit shall promote health and safety of the people;

WHEREAS, construction and discarded materials stored along the portion of the road not only pose imminent danger to general public using the road but likewise suppress the flow of traffic.
