RESOLUTION NO. 27 S. 2019

RESOLUTION REQUESTING THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB) TO RETAIN THE EXISTING NUMBER OF UNITS OF PUBLIC UTILITY JEEPNEYS (PUJS) IN BATANGAS CITY IN VIEW OF THE PUBLIC UTILITY VEHICLE (PUV) MODERNIZATION

WHEREAS, Department of Interior and Local Government (DILG) and Department of Transportation (DoTr) Joint Memorandum Circular No. 001, Series of 2017, dated June 19, 2017 was issued mandating all Provincial, City, Municipal Governments, Autonomous Regions, Special Areas, and Regional Offices of the DILG and DoTr through the Land Transportation Franchising and Regulatory Board (LTFRB) nationwide to prepare and issue local ordinances concerning the Local Public Transport Route Plan (LPTRP):

WHEREAS, Land Transportation Franchising and Regulatory Board (LTFRB) came up with the Local Public Transport Route Plan (LPTRP) Manual which would serve as the guide to all Local Government Units (LGUs) in the identification, designing and planning of routes by indicating the pertinent guidelines, policies, data requirements and data collection methodologies involved in the formulation of LPTRP, which shall be subject to the approval of the LTFRB:

WHEREAS, upon analyzing the public transport supply and demand (using the formulas and methodologies specified in the LPTRP Manual), every Local Government Unit is required to submit the proposed number of Public Utility Jeepneys (PUJs) in its jurisdiction per route, which will be subject to the approval of the LTFRB;
