RESOLUTION NO. 319 S. 2019

GRANTING THE AUTHORITY FOR THE HONORABLE CITY MAYOR BEVERLEY ROSE A. DIMACUHA TO SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH GENCO/ERD FOR THE ESTABLISHMENT AND ADMINISTRATION OF THE DEVELOPMENT LIVELIHOOD FUND (DLF) AND REFORESTATION, WATERSHED MANAGEMENT, HEALTH AND/OR ENVIRONMENT ENHANCEMENT FUND (RWMHEEF) TRUST ACCOUNTS IN ACCORDANCE WITH DC2018-08-0021

WHEREAS, the Department of Energy (DOE) issued a Department Circular No. DC2018-08-0021, amending for the purpose Rule 29 (A) of the Electric Power Industry Reform Act of 2001 of its Implementing Rules and Regulations (EPIRA-IRR), to accelerate socio economic development and to have a more effective and efficient utilization of the funds and to enforce the immediate provision of benefits to host communities;

WHEREAS, pursuant to Section 6 of DC2018-08-0021, the financial benefit from the GenCo in favor of the Host Local Government Unit (LGU) shall be allocated in the following manner: Twenty-five percent (25%) of one-centavo per kilowatt-hour for Development and Livelihood Fund (DLF); and twenty-five percent (25%) of one-centavo per kilowatt-hour for Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF). The DLF and RWMHEEF shall be allocated in the following manner: 5% for Community and people affected; 20% for host barangays; 35% for host city; 30% for host province; 5% for host ICCs/IPs; and 5% for host region;

WHEREAS, this agreement shall cover the establishment and administration by the Host Beneficiary of separate trust accounts for DLF and RWMHEEF;

GRANT OF AUTHORITY FOR THE ESTABLISHEMNT AND ADMINISTRATION OF THE DEVELOPMENT AND LIVELIHOOD FUND (DLF) AND REFORESTATION, WATERSHED MANAGEMENT, HEALTH AND/OR ENVIRONMENT ENHANCEMENT FUND (RWMHEEF) TRUST ACCOUNTS IN ACCORDANCE WITH DC2018-08-0021

BACKGROUND:

The subject request for the grant of authority, was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on September 10, 2019. The Committee held a hearing on September 16, 2019 and in attendance were the following:

COMMENTS:

Pursuant to Section 6 of DC2018-08-0021, the financial benefit from the GenCo in favor of the Host Local Government Unit (LGU) shall be allocated in the following manner: Twenty-five percent (25%) of one-centavo per kilowatt-hour for Development and Livelihood Fund (DLF); and twenty-five percent (25%) of one-centavo per kilowatt-hour for Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF).
