COMMITTEE REPORT

DRRM TRUST FUND PLANS AND PROGRAM FOR CY 2019 TO BE CHARGED AT THE LDRRM TRUST FUND AMOUNTING TO P12,000,000.00 PESOS FOR THE PURCHASE OF LARVICIDE/INDOOR RESIDUAL SPRAY POWDER FOR DENGUE AND EQUIPMENT FOR SPRAYING ACTIVITY AND LONG LASTING INSECTICIDE TREATMENT SCREENS FOR DENGUE PREVENTION AND CONTROL

BACKGROUND:

The subject request for the utilization of fund was referred to the Committee on Appropriations for its consideration during the Regular Session on October 15, 2019. The Committee held a hearing on October 16, 2019 and in attendance were the following:

From City Disaster Risk Reduction and Management Council: Mr. Rodrigo Dela Roca; from City Accounting Office: Mrs. Sherryl B. Bool; from CPDO: Engr. Januario B. Godoy; from City Treasurer's Office: Mrs. Aster P. Marasigan; from City Budget Office: Mrs. Elizabeth Q. Delos Reyes; from City Mayor's Office: Mr. Manolo N. Perlada; and from City health Office: Mr. Leonelus Quinio and Mrs. Susana Mira. Also present are the Chairperson Coun. Alyssa Renee A. Cruz and the committee members Coun. Oliver Z. Macatangay and Coun. Nelson Chavez. The Vice Mayor Hon. Emilio Francisco A. Berberabe Jr. and other members of the Sangguniang Panlungsod Councilors Nestor E. Dimacuha, Isidra M. Atienza, Maria Aleth Lazarte, Lorenzo A. Gamboa Jr. and ABC President Angelito A. Dimacuha were also present.

COMMENTS:

During the committee hearing, the CDRRMC Officer made an introductory statement regarding the DRRM Trust Fund Plan and Program of the City Disaster Risk Reduction Management Council (CDRRMC) for Calendar Year 2019.

It was also reiterated that the said request is intended to minimize the risk and vulnerabilities and ensure the public safety of every Batangueño. The said DRRM Trust Fund Plans and Program to be charged at the LDRRM Trust Fund, will be used for the purchase of Larvicide/Indoor Residual Spray Powder for Dengue and Equipment for Spraying activity and Long Lasting Insecticide Treatment Screens for Dengue Prevention and Control for a total of twelve Million Pesos (P12,000,000.00).

Finally, it was mentioned that the previously approved ordinance utilizing a portion of the 30% CDRMC Quick Response Fund amounting to P 15,000,000. for the conduct of dengue-awareness campaigns, community participation through Dengue Brigades, and assistance in the mobilization of logistics and conduct of chemical interventions should not be withdrawn after the passage of this ordinance.

RECOMMENDATIONS:

Finding no legal impediment for the approval of the requested utilization, the Committee recommends the approval of request of the Honorable City Mayor.

In view of the foregoing, the Committee hereby recommends:

1. The adoption of this Committee Report.
2. The approval of an Ordinance hereto attached.
