WHEREAS, the City of Batangas is dutifully engaged in its Local Climate Change Action Plan (LCCAP) wherein mitigation and adaptation measures are major components including GhG emission management based from results of the periodic conduct of GhG accounting/inventory. The 2017 inventory results show that transportation is the 2nd highest emitting sector of GhG;

WHEREAS, Section 4, Part 1 of the City's LCCAP identifies "Promotion of the Use of Electric Vehicles and Bicycles" as one of the major mitigation initiatives for the transportation sector and is lined up for implementation;

WHEREAS, the City of Batangas recently expressed its intention to be selected as grantee of E-Trikes under the DOE's Market Transformation through the Introduction of Energy Efficient Electric Vehicles (E-Trike) Project;

WHEREAS, as part of the DOE's Market Transformation through the Introduction of Energy Efficient Electric Vehicles (E-Trike) Project, DOE requires the interested LGU to provide a Sanggunian Resolution allowing the Mayor to sign a Deed of Donation;
