**A RESOLUTION URGING THE CREATION OF A FACT-FINDING TEAM TO BE
LED BY CDRRMO TO ASCERTAIN THE PERTINENT CAUSE OF THE DISASTER
IN BARANGAY DELA PAZ, BATANGAS CITY**

WHEREAS, on November 27, 2022 at around 4 pm, the project under construction in Barangay Dela Paz, Batangas City collapsed causing insurmountable damage;

WHEREAS, the damage in the said construction project was apparently caused by human error which led to the endangerment of workers and property;

WHEREAS, there is an urgent need for the City Government to look into this matter and file a report to the Office of the City Mayor and to the Sangguniang Panlungsod regarding the said incident;

NOW, THEREFORE, BE IT RESOLVED AS IT HEREBY RESOLVES, by the Sangguniang Panlungsod in session assembled, to create a fact-finding team to be led by Mr. Rodrigo Dela Roca and Engr. Dwight Arellano effective immediately.
