**FINDINGS:**

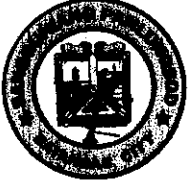
The Chairman of the Committee on Appropriations, the members of the Committee, and Members of the Sangguniang Panlungsod briefly made an overview of the subject and stated the following:

1. The Sangguniang Barangays and SK Councils discussed all their respective Annual Budget 2024;
2. The annual budget hearing of the Sangguniang Barangays and SK Councils seek to know if their respective budgets are anchored to Article 2 Section 329-332 of the Local Government Code;
3. The Sangguniang Panlungsod fully supported all the Sangguniang Barangays and SK Councils in terms of budget-making and is open to all inquiries regarding budget policies and budget-making processes.
4. Barangays and SK Councils shall exercise taxing power, but shall draft a tax ordinance and conduct a public hearing as stated in Section 186 of the Local Government Code of 1991.
5. The Sangguninag Panlungsod members stated that the barangays and SK Councils must refer to the Budget Operations Manual and can ask for the assistance of the Local Finance Committee for further review and comments.




