WHEREAS, a judicious review, evaluation and analysis of each of the barangay annual budgets submitted to the Sangguniang Panlungsod show substantial compliance with law and all budgetary rules and regulations

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the aforementioned Barangay Budgets for CY 2013, to wit:

These annual barangay budgets for CY 2013 are therefore considered operative and effective on January 1, 2013 in accordance with Section 332 of R.A. 7160.
