**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS FOR
CALENDAR YEAR 2013 OF DIFFERENT BARANGAYS INCLUDING SK BUDGETS**

WHEREAS, a review of the Supplemental Budgets of different Barangays including SK Budgets shows substantial compliance with the provisions of the Local Government Code of 1991.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the following Barangay Supplemental Budgets and SK Supplemental Budget for the purposes the amounts were appropriated:

COMPLIANCE. Compliance to the provisions of the Budget Operations Manual for LGUs issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.

EFFECTIVITY. The approved Supplemental Budgets of each barangay shall take effect upon its approval by the Sangguniang Barangay concerned or on the date fixed in the Barangay Ordinance as provided in Article 416 IRR and Section 332 LGC.

Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangay, through its Punong Barangay, SK Chairman and to the City Budget Officer.


