ST. BRIDGET COLLEGE, AS IT CELEBRATES THE 100TH FOUNDATION
ANNIVERSARY ON FEBRUARY 01, 2013 - THE PURVEYOR OF THE
FIRST CATHOLIC EDUCATION IN THE PROVINCE OF BATANGAS

WHEREAS, the City Government of Batangas, acting through the Sangguniang Panlungsod, joins the Religious of the Good Shepherd and all Bridgetines, as St. Bridget College celebrates its Centennial Anniversary, so timely and so blissful, as it coincides with a very important milestone in history of the church, the Papal Pastoral letter "Porta Fidei" (Year of Faith);

WHEREAS, in retrospect, St. Bridget College was founded upon the request and promptings of Most Reverend Guiseppe Petrelli, First Bishop of the Diocese of Lipa, the canonical erection of which took place in April 10, 1910;

WHEREAS, in response to the call, two RGS Irish nuns - Sr. Mary Constance Phelan and Sr. Mary Liquori Burke arrived in the then Batangas, Batangas from Burma, followed later by Sr. Mary Claire Morisey who began offering informal classes for girls which in June 1913 was given official government recognition, and was duly incorporated under Philippine laws, as St. Bridget's Academy, so named after St. Bridget of Ireland.

WHEREAS, St. Bridget College, as it observes its Centennial Anniversary, stands strong, dedicated and committed in fulfilling its Vision-Mission, crafted and honed according to the missionary zeal and charism of St. Mary Euphrasia;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that this RESOLUTION OF COMMENDATION, CONGRATULATIONS AND FELICITATION TO ST. BRIDGET COLLEGE, AS IT CELEBRATES THE 100TH FOUNDATION ANNIVERSARY ON FEBRUARY 01, 2013 - THE PURVEYOR OF THE FIRST CATHOLIC EDUCATION IN THE PROVINCE OF BATANGAS be approved by this august body.
