WHEREAS, a judicious review, evaluation and analysis and favorable recommendation of the City Budget Officer of the Annual Budget of Barangay Malitam for Calendar Year 2013 submitted to the Sangguniang Panlungsod for review, the said budget shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the aforementioned Barangay Budget for CY 2013, to wit:

Any change in the annual budget shall be in accordance with the provisions of Section 321 and 336 of the Local Government Code.

The annual barangay budget for CY 2013 of Barangay Malitam, Batangas City in the amount of P3,285,521.00 is therefore considered operative and effective as of January 1, 2013 in accordance with Section 332 of R.A. 7160.
