FINDINGS:

The Chairman of the Committee on Appropriations, the members of the Committee, and Members of the Sangguniang Panlungsod briefly made an overview of the subject and stated the following:

1. The Sangguniang Barangays and SK Councils discussed all their respective Annual Budget 2024;
2. The sole purpose of the discussion is to know if their budget is integrated to the Barangay Annual Investment Plan;
3. The annual budget hearing of the Sangguniang Barangays and SK Councils seeks to know if their respective budgets are anchored to Article 2 Section 329-332 of the Local Government Code;
4. The members of the Local Finance Committee stated that the SK Council's projects must be integrated to the Philippine Youth Development Plan and must adopt the Sustainable Development Goals (SDGs);
5. The Sangguniang Panlungsod fully supports all the Sangguniang Barangays and SK Councils in terms of budget-making and is open to all inquiries regarding budget policies and budget-making processes.
