"BAC RESOLUTION NO. 2.34, 418

RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF GOODS AND COMMODITIES

- WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and instill health consciousness among them:
- WHEREAS, Section 48, Rule XVI. Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the sovernment will be obtained;
- WHEREAS, Negotiated Procurement under Emergency Cases may be resorted in case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other cases where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastracture facilities and other public utilities.
- WHEREAS, Hon. City Mayor Beverley Rose A. Dimacuha signed Executive Order No. 36 s. 2021 on September 16, 2021, declaring State of Calamity in Batangas City due to Typhoon Jolina, moreover, Batangas City, still under the General Community Quarantine with heightened restrictions, is still experiencing PANDEMIC due to the spread of Corona Virus, thus, the movement of the residents are limited, even their respective jobs are affected thereby making it impossible to buy their primary staple, hence this move by the City Government to distribute food packs to Batangas City residents affected by this pandemic:
- WHEREAS, the spike in the number of COVID19 positive patients has been in its all-time high since the onset of PANDEMIC, infecting even the frontliners, including medical personnel assigned to look after patients in the city government's temporary isolation facilities;
- WHEREAS, this pandemic has affected the lives of practically everyone, hence this move by the city government to provide goods to the families living in 105 barangays of Batangas City that would immensely help the city government's thrust to minimize, if not stop the virus as it would limit their movements. Thereby lessening the chance of more community transmission;
- WHEREAS, the Approved Purchase Request (PR) No. 1670S charged under General Fund dated September 20, 2021 for the Supply and Delivery of Goods and Commodities to be distributed in 105 Barangays of Batangas City for the families affected by the PANDEMIC amounting to Eighty Eight Million One Thousand Three Hundred Pesos (Pha88.00.13.00.0) was indorsed to the Bilds and Awards Committee (BAC);
- WHEREAS, the Bids and Awards Committee is authorized to resort to Alternative Mode of Procurement in accordance with the provisions of RA 9184, under Section 53.2 (Negotiated Procuremet-Emergency Cases) as per approved authority;

WHEREAS.

it appearing that the price offered by **BATANGAS CITIMART SHOP-ON, INC.** with business address located at <u>Rizal Avenue</u>, <u>Pob. 16</u>, <u>Batangas City</u> was found to be the most reasonable and advantageous to the City Government, if accepted;
